4	SECTION 2. This Act shall not be applied so as to impair			
5	any contract existing as of the effective date of the Act in a			
6	manner violative of either the Constitution of the State of			
7	Hawaii or article I, section 10, of the United States			
8	Constitution.			
9	SECTION 3. The provisions of this Act shall be enforced to			
10	the extent they are not held to conflict with any federal or			
11	state constitutional provision, law, rule, or regulation. The			
12	provisions of this Act are not severable and if any provision of			
13	the Act, or the application therof to any person or circumstance			
14	is held to conflict with any deferral or state constitutional			
15	provision, law, rule, or regulation, this Act, in its entirety			
16	shall be invalid.

To exempt government-owned or government-sponsored vessels, training vessels, and fishing vessels from the requirement that the securing of mooring lines from vessels to the State's commercial docks, wharves, piers, quays, and landings be performed by

labor that is subject to collective

bargaining.

MEANS:

Amend section 266-61, Hawaii Revised

Statutes (HRS).

JUSTIFICATION:

Act 236, Session Laws of Hawaii (SLH) 2024, amended chapter 266, HRS, to add a new section requiring that the securing of mooring lines from vessels to the State's commercial docks, wharves, piers, quays, and landings be performed by labor subject to collective bargaining. Several vessel types were identified as appropriate to be exempt from the new requirement. Additional vessel types have been identified as appropriate to be exempt from the requirement.

Impact on the public: Act 236, SLH 2024, allowed regulated intrastate shipping companies to use their current qualified staff to safely and more efficiently conduct their necessary mooring operations. Government-owned or government-sponsored vessels, training vessels, and fishing vessels are appropriate to exempt from those requirements without the same concerns.
