### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

•	SECTION 1: The purpose of this Act is to prohibit the sale		
2	or offer for sale or distribution of manufactured hemp products		
3	to individuals under the age of twenty-one, thereby protecting		
4	public health and ensuring responsible consumption of hemp-		
5	derived products.		
6	SECTION 2. Chapter 328G, Hawaii Revised Statues, is		
7	amended by adding a new section to be appropriately designated		
8	and to read as follows:		
9	"§328G- Manufactured hemp product; sale to persons		
10	under twenty-one prohibited. (a) No person shall sell or offer		
11	for sale or distribution any manufactured hemp product to any		
12	individual under the age of twenty-one years.		
13	(b) No retailer shall sell manufactured hemp products		
14	except in direct face-to-face or online direct shipment		
15	exchanges between the retailer and a consumer.		
16	(c) A retailer shall verify the age of any individual		
17	attempting to purchase manufactured hemp products by checking a		
18	valid government-issued photo identification; provided that an

1	online retailer shall either obtain a copy of a valid			
2	government-issued photo identification or use an age-

5	(d) Any manufactured hemp products offered for sale shall			
6	be displayed or stored:			
7	(1) Behind a sales counter or in any other area of the			
8	establishment that is inaccessible to the public; or			
9	(2) In a locked container.			
10	(e) A retailer shall prominently display a notice on its			
11	premises and website indicating that the sale of manufactured			
12	hemp products to anyone under the age of twenty-one years is			
13	prohibited.			
14	(f) Any person who violates this section shall be fined			
15	pursuant to section 328G-6.			
16	(g) For the purpose of this section, "retailer" means a			
17	person who engages in the practice of selling manufactured hemp			
18	products to consumers. "Retailer" includes its agents and			
19	employees."

MEANS:

Add a new section to chapter 328G, Hawaii

Revised Statutes (HRS).

JUSTIFICATION:

The U.S. Centers for Disease Control and Prevention recommends against using hemp-derived products for children due to the presence of cannabidiol in them. Hemp-

derived products may also contain

tetrahydrocannabinol or other intoxicating cannabinoids, which can prove detrimental to

developing brains.

Impact on the public: The bill will prevent the sale of manufactured hemp products to individuals under the age of twenty-one, thereby protecting public health and ensuring responsible consumption of hemp-

derived products.

rules to enforce this section.
