#### A BILL FOR AN ACT

RELATING TO UNIVERSAL IMMUNIZATION FUNDING PROGRAM.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that fourteen states have
2	adopted programs known as "Universal Purchase" or "Universal
3	Select" (collectively, UP), providing state-purchased access to
4	some or all recommended immunizations to children and adults in
5	those states. UP immunization purchases occur at a discounted
6	price through contracts otherwise intended for more established
7	and familiar immunization purchasing programs such as the
8	Vaccines For Children Program (Pub. L. 103-66) and Public Health
9	Services Act, Section 317 Immunization Program (Pub. L. 78-410).
10	Other varied state approaches include superseding private
11	sources of coverage and assessing health insurance plans for the
12	cost of the program and disallowing provider use of private
13	immunization stock.
14	The legislature further finds that states with UP programs
15	that allow state health officials to manage the supply of
16	immunizations lowered health care providers' administrative
17	costs and ensured that the states can quickly supply
18	immunizations to vulnerable patient groups during emergencies or

- 1 immunization shortages. The potential benefits to Hawaii's2 health care and public health system make investment in a UP
- 3 program worthwhile.
- 4 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 5 amended by adding a new part to be appropriately designated and
- 6 to read as follows:
- 7 "PART . UNIVERSAL IMMUNIZATION FUNDING PROGRAM
- 8 §321- Definitions. As used in this part, unless the
- 9 context otherwise requires:
- 10 "Adult covered lives" means all adults under the age of
- 11 sixty-five who have immunizations covered:
- 12 (1) By an individual health insurance policy issued or
- delivered in the State;
- 14 (2) By a group health insurance policy issued or delivered
- in the State;
- 16 (3) By a group health insurance policy evidenced by a
- 17 certificate of insurance issued or delivered to an
- 18 individual residing in the State;
- 19 (4) By an employee benefit plan of a self-insured entity
- or a government plan for any employer or government
- 21 entity that has an office or other worksite located in
- the State or has two or more employees; or

1	(5) As a participant or beneficiary of a health cost	
2	sharing program.	
3	"Assessed entity" means any insurer in the State, that is	
4	not federally funded, issuing individual and group accident and	
5	health or sickness insurance policies, individual or group	
6	hospital or medical service plan contracts, and nonprofit mutual	
7	benefit society, fraternal benefit society, and health	
8	maintenance organization health plans.	
9	"Assessment" means the association member liability with	
10	respect to immunization costs determined in accordance with this	
11	part.	
12	"Child covered lives" means all children aged eighteen	
13	years or younger who have immunizations covered:	
14	(1) By an individual health insurance policy issued or	
15	delivered in the State;	
16	(2) By a group health insurance policy issued or delivered	
17	in the State;	
18	(3) By a group health insurance policy evidenced by a	
19	certificate of insurance issued or delivered to an	
20	individual residing in the State;	
21	(4) By an employee benefit plan of a self-insured entity	
22	or a government plan for any employer or government

T	entity that has an office or other worksite located in	
2	the State or has two or more employees; or	
3	(5) As a participant or beneficiary of a health cost	
4	sharing program.	
5	"Department" means the department of health.	
6	"Director" means the director of health or designee.	
7	"Estimated adult immunization cost" means the estimated	
8	cost to the State for the purchase and distribution of adult	
9	immunizations purchased at the federal discount rate.	
10	"Estimated pediatric immunization cost" means the estimated	
11	cost to the State for the purchase and distribution of child	
12	immunizations purchased at the federal discount rate.	
13	"Health carrier" means an entity subject to the insurance	
14	laws and rules of the State, or subject to the jurisdiction of	
15	the insurance commissioner, that contracts or offers to contract	
16	to provide, deliver, arrange for, pay for, or reimburse any of	
17	the costs of health care services, including an insurance	
18	company, a health maintenance organization, a mutual benefit	
19	society, or any other entity providing a plan of health	
20	insurance, health benefits, or health services.	
21	"Health cost sharing program" means any cost sharing or	
22	similar program that seeks to share the costs of health care	

- 1 services and that in the preceding twelve months either has
- 2 coordinated payment for or reimbursed over \$10,000 of costs for
- 3 health care services delivered in the State or communicated by
- 4 mail or electronic media to residents of the State concerning
- 5 their potential participation.
- 6 "Immunization" means any preparation of killed
- 7 microorganisms, living attenuated organisms, or living fully
- 8 virulent organisms of mRNA or any other injectable treatment
- 9 intended to trigger an immune response that is authorized by the
- 10 United States Food and Drug Administration and recommended by
- 11 the national Advisory Committee on Immunization Practices of the
- 12 United States Centers for Disease Control and Prevention and has
- 13 been authorized for purchase by the director for the purposes of
- 14 producing or artificially increasing immunity to particular
- 15 diseases. For purposes of this part, "immunization" shall
- 16 include any other substance designated as such by order of the
- 17 director.
- 18 "Provider" means a person licensed by the State to
- 19 administer immunizations or provide health care services or a
- 20 partnership or corporation or other entity made up of those
- 21 persons.

1	§321- Universal immunization purchase special fund;	
2	established. (a) There is established in the state treasury	
3	the universal immunization purchase special fund into which	
4	shall be deposited fees, fines, and cost reimbursements paid by	
5	assessed entities. The fund shall be administered and expended	
6	by the department.	
7	(b) Expenditures from the fund shall be used for the	
8	purchase of immunizations and the administration of the program,	
9	at no cost to providers, to administer to individuals who are	
10	not eligible to receive immunizations at no cost through other	
11	programs.	
12	(c) The department may contract with other entities for	
13	any services pursuant to this part.	
14	§321- Assessments. (a) The director shall determine	
15	regular immunization assessment rates as follows:	
16	(1) Provide estimated child immunization costs and	
17	estimated adult immunization costs, not covered by any	
18	other state or federal funds, for the succeeding year	
19	no later than one hundred twenty days prior to the	

commencement of each fiscal year;

1	(2)	Add estimates to cover the department's operating
2		costs for the universal immunization purchase special
3	·	fund program;
4	(3)	Add a reserve of up to ten per cent of the sum of the
5		preceding fiscal year and for unanticipated costs;
6	(4)	Add a working capital reserve in such amount as may be
7		reasonably determined by the director;
8	(5)	Subtract the amount of any unexpended fund balance,
9		including any net investment income earned, as of the
10		end of the preceding fiscal year; and
11	(6)	Calculate a per-child covered life per month and per-
12		adult covered life per month amount to be self-
13		reported and paid by all assessed entities by dividing
14		the annual amount determined in accordance with
15		paragraphs (1) through (5) by the number of children
16		and adults, respectively, projected to be covered by
17		the assessed entities during the succeeding program
18		year, divided by twelve.
19	(b)	No later than forty-five days following the close of
20	the state	fiscal year, the department shall provide an
21	accounting	g of immunization purchase funds not covered by any

- 1 state or other program to determine the final amount needed to
- 2 cover the prior fiscal year.
- 3 Unless determined by the director, any assessed entity that
- 4 would otherwise be responsible for reimbursement to any provider
- 5 for any immunization administration shall be responsible for
- 6 reporting the child covered life and adult covered life and for
- 7 payment of the corresponding assessment to the department.
- 8 (c) At any time after one full calendar year of operation
- 9 under subsections (a) and (b), the director may make changes to
- 10 the assessment collection mechanism. Any such changes shall be
- 11 reflected in an updated plan of operation available to the
- 12 public.
- 13 (d) If an assessed entity has not paid in accordance with
- 14 this section, interest accrues at one per cent per month,
- 15 compounded monthly on or after the due date.
- 16 (e) The director may determine an interim assessment for
- 17 new immunizations or public health emergencies and shall
- 18 calculate a supplemental interim assessment using the
- 19 methodology outlined under subsection (a) for regular
- 20 assessments, but payable over the remaining fiscal year, and
- 21 such interim assessment shall be payable together with the
- 22 regular assessment commencing the calendar quarter that begins

- 1 no less than thirty days following the establishment of the
- 2 federal contract price. The director may not impose more than
- 3 one interim assessment per year, except in the case of a public
- 4 health emergency declared in accordance with state or federal
- 5 law.
- 6 (f) For purposes of assessments, medical loss ratio
- 7 calculations, and reimbursement by plan sponsors, all
- 8 association assessments are considered pharmaceutical or medical
- 9 benefit costs and not regulatory or administrative costs.
- 10 (g) If the department discontinues operation of the
- 11 universal immunization funding program for any reason, any
- 12 unexpected assessments, including unexpended funds from prior
- 13 assessments in the immunization purchase fund, shall be refunded
- 14 to payees in proportion to the respective assessment payments by
- 15 payees over the most recent eight quarters before
- 16 discontinuation of program operations.
- 17 §321- Reports and audits. (a) Each assessed entity
- 18 shall report its number of child and adult covered lives
- 19 according to a schedule determined by the director and respond
- 20 to any requests by the director related to covered lives or
- 21 assessments due. Any assessed entity that fails to respond to
- 22 an audit request within ten business days of the receipt of

- 1 notification of audit request shall be responsible for prompt
- 2 payment of fees of any outside auditor engaged by the department
- 3 to determine such information and shall make all records
- 4 requested by the department-engaged auditors available for
- 5 inspection and copying at such location within the State as
- 6 specified by the auditor.
- 7 (b) Each provider administering immunizations in the State
- 8 that are supplied via federal vaccination programs or the
- 9 universal immunization funding program shall report to the
- 10 Hawaii immunization registry pursuant to section 325-122, such
- 11 data related to immunizations as the department determines is
- 12 necessary for disease prevention, control, and immunization
- 13 inventory management and accountability purposes.
- 14 (c) Failure to cure non-compliance with any reporting,
- 15 auditing, or assessment obligation to the department within
- 16 thirty days from the postmarked date of written notice of
- 17 noncompliance may subject the assessed entity to fines
- 18 established pursuant to subsection (d). Any monetary fine, fee,
- 19 or cost reimbursement shall be remitted to the universal
- 20 immunization purchase special fund.
- 21 (d) Any entity that violates this chapter shall be fined
- 22 no more than \$1,000 for each separate offense. Each date of

- 1 violation shall constitute a separate offense. The assessed
- 2 entity shall also pay for reasonable attorney's fees and any
- 3 other costs of enforcement under this section. Any action taken
- 4 to impose or collect the penalty provided for in this subsection
- 5 shall be considered a civil action.
- 6 §321- Immunity. Apart from liabilities of assessed
- 7 entities pursuant to this part, there shall be no liability on
- 8 the part of and no cause of action against the department,
- 9 independent contractors, or employees for any action or omission
- 10 in the course of operating the universal immunization purchase
- 11 program.
- 12 §321- Rulemaking. The department may adopt rules
- 13 pursuant to chapter 91 to carry out the purposes of this part.
- 14 §321- Available choices. The department shall maintain
- 15 a list of immunizations, including all brand choices available
- 16 for purchase by the State on the United States Centers for
- 17 Disease Control and Prevention contract, for which costs are
- 18 funded pursuant to this part.
- 19 §321- Immunization cost reimbursement to providers;
- 20 limits. This part shall have no impact on amounts paid to
- 21 providers to administer immunizations. No provider may bill any

1	assessed entity or any other person for any immunizations	
2	supplied at no cost by the State."	
3	SECTION 3. There is appropriated out of the general	
4	revenues of the State of Hawaii the sum of \$ or so	
5	much thereof as may be necessary for the fiscal year 2025-2026	
6	to be deposited into the universal immunization purchase special	
7	fund.	
8	SECTION 4. There is appropriated out of the universal	
9	immunization purchase special fund the sum of \$ or so	
10	much thereof as may be necessary for fiscal year 2025-2026 for	
11	startup operations and initial procurements for the universal	
12	immunization funding program.	
13	The sum appropriated shall be expended by the department of	
14	health for the purposes of this Act.	
15	SECTION 5. This Act, upon its approval, shall take effect	
16	on July 1, 2025.

#### Report Title:

Establishes the Universal Immunization Purchase Special Fund into which the fees will be deposited to finance the distribution of immunizations free of charge to qualifying healthcare providers.

TITLE:

A BILL FOR AN ACT RELATING TO UNIVERSAL

IMMUNIZATION FUNDING PROGRAM.

PURPOSE:

To establish the universal immunization purchase special fund for the purpose of equitably collecting and distributing assessments for the cost of immunizations in Hawaii that are not covered by other funding sources. Assessed funds will be made available to the Department for the purpose of procuring immunizations and administering the program through federal or other contracts for administration to individuals

contracts for administration to individuals not otherwise eliquible for other programs.

MEANS:

Add a new part to chapter 321, Hawaii Revised Statutes, and appropriate funds.

JUSTIFICATION:

Immunizations prevent morbidity and mortality from many diseases in millions of children and adults. A more centralized procurement and storage program can contribute to higher immunization rates in the community by minimizing supply chain disruptions caused by shortages or geographic disparities. During a public health emergency for which immunizations play an important role, the economies of scale and improved logistics can improve community-wide surveillance more quickly and accurately than the current fragmented distribution and delivery systems.

In Hawaii, the purchase of immunizations is conducted by the Department through federal immunization programs, and by private health care providers or health systems. Private providers take on considerable risk because of the need to pay for their immunization supplies up front, as well as incurring other expenses such as secure and temperature-controlled storage. A universal purchasing program will reduce the financial

and administrative burden to health care providers and create economies of scale that can reach more patients than the current uncoordinated model.

Impact on the public: The Department's ability to leverage highly competitive federal immunization purchasing contracts may result in lower overall costs to Hawaii's health system, as well as increased rates of immunizations that will lower incidences of immunization-preventable diseases.

Impact on the department and other agencies: Immunizations are required for public school attendance so the Department of Education may have more eligible students due to wider availability of immunizations.
