A BILL FOR AN ACT

RELATING TO MOTORCYCLE INSTRUCTION PERMITS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The purpose of this Act is to require, starting
 on July 1, 2026, that applicants for a motorcycle instruction
 permit successfully complete a basic motorcycle rider course
 approved by the department of transportation before becoming
 eligible for the permit.
- 6 SECTION 2. Section 286-110, Hawaii Revised Statutes, is 7 amended to read as follows:
- 8 "§286-110 Instruction permits. (a) Any person aged
- ${f 9}$ fifteen years and six months or more who, except for the
- 10 person's lack of instruction in operating a motor vehicle, would
- 11 be qualified to obtain a driver's license issued under this part
- 12 may apply for a temporary instruction permit or a limited
- 13 purpose instruction permit at the office of the examiner of
- 14 drivers in the county in which the applicant resides; provided
- 15 that the applicant compliles with section 286-102.5.
- (b) No person shall be issued a motorcycle instruction
- 17 permit unless the person successfully completes a basic

2 transportation. 3 [(b)] (c) The examiner of drivers shall examine every 4 applicant for an instruction permit. The examination shall 5 include tests of the applicant's: 6 Eyesight and other physical or mental capabilities to 7 determine if the applicant is capable of operating a 8 motor vehicle; 9 (2) Understanding of highway signs regulating, warning, **10** and directing traffic; and 11 Knowledge of the traffic laws, ordinances, or (3) **12** regulations of the State and the county where the **13** applicant resides or intends to operate a motor 14 vehicle. 15 [(c)] (d) If the examiner of drivers is satisfied that the 16 applicant is qualified to receive an instruction permit, the **17** examiner of drivers shall issue the permit entitling the 18 applicant, while having the permit in the applicant's immediate 19 possession, to drive a motor vehicle upon the highways for a 20 period of one year; provided that: 21 (1) An applicant who is registered in a driver training 22 course shall be issued a temporary instruction permit

3	(2) If the applicant is a legal immigrant, the permit

6	A person who is not licensed to operate the category of		
7	motor vehicles to which the driving training course applies		
8	shall not operate a motor vehicle in connection with the driving		
9	training course without a valid temporary instruction permit.		
10	[(d)] <u>(e)</u> Except when operating a motor scooter or		
11	motorcycle, the holder of an instruction permit shall be		
12	accompanied by a person who is twenty-one years of age or older		
13	and licensed to operate the category of motor vehicles in which		
14	the motor vehicle that is being operated belongs. The licensed		
15	person shall occupy a passenger seat beside the permit holder		
16	while the motor vehicle is being operated; provided that if the		
17	holder of the instruction permit is under the age of eighteen		
18	years and is driving between the hours of 11:00 p.m. and 5:00		
19	a.m.:		
20	(1) A licensed driver who is the permit holder's parent or		
21	guardian shall occupy a passenger seat beside the

2		permit holder is an emancipated minor;	
3	(2)	The licensed driver shall be licensed to operate the	
4		same category of motor vehicles as the motor vehicle	
5		being operated by the holder of the instruction	
6		permit; and	
7	(3)	All occupants of the motor vehicle shall be restrained	
8		by a seat belt assembly or a child passenger safety	
9		restraint system as required under sections 291-11.5	
10		and 291-11.6, notwithstanding any other law to the	
11		contrary.	
12	[(e)]	(f) No holder of a temporary instruction permit shall	
13	operate a motorcycle or a motor scooter during hours of darkness		
14	or carry any passengers.		
15	[-(£)-]	(g) No holder of a category 1 or 2 temporary	
16	instruction permit shall have the permit renewed, nor shall the		
17	holder be issued another temporary instruction permit for the		
18	same purpose, unless the holder has taken the examination for a		
19	category 1 or 2 license at least once prior to the expiration of		
20	the temporary instruction permit. If the holder of a temporary		
21	instruction permit fails to meet the requirements of this		
22	section, the holder shall not be permitted to apply for another		

- 1 category 1 or 2 temporary instruction permit for a period of
- 2 three months. Nothing in this subsection shall affect the right
- 3 and privilege of any holder of a category 1 or 2 temporary
- 4 instruction permit to obtain a temporary instruction permit or
- 5 driver's license for the operation of any other type of motor
- 6 vehicle.
- 7 [(g)] (h) The examiner of drivers may accept an application
- 8 for renewal of an instruction permit no more than thirty days
- 9 prior to or ninety days after the expiration date of the
- 10 instruction permit, whereupon the applicant for renewal of an
- 11 instruction permit shall be exempt from subsection [-(b)-(2) and
- (3). (c) (2) and (3). If an application for renewal of an
- 13 instruction permit is not made within ninety days after the
- 14 expiration date of the permit, the applicant shall be treated as
- 15 applying for a new instruction permit and examined in accordance
- 16 with subsection [-(b). (c).
- 17 [(h)] (i) Notwithstanding any other law to the contrary,
- 18 the examiner of drivers may issue an instruction permit to an
- 19 applicant with a disability who has completed a medical review
- 20 with this State, and as a condition to licensure is required to
- 21 pass a road test, but has failed the road test on the
- 22 applicant's first attempt. The instruction permit issued under

- 1 this subsection may be renewed no more than thirty days prior to
- 2 or ninety days after the expiration date of the instruction
- 3 permit upon receiving an updated medical report. Subsections
- 4 [(b)(2) and (3)] (c)(2) and (3) shall not apply to the issuance
- 5 or renewal of an instruction permit issued under this
- 6 subsection.
- 7 For the purposes of this subsection, "applicant with a
- 8 disability" means an applicant who the examiner of drivers has
- 9 reasonable cause to believe may have a mental or physical
- 10 infirmity or disability that would make it unsafe to operate a
- 11 motor vehicle pursuant to section 286-119(a)(1) and has been
- 12 medically evaluated by the medical advisory board established
- 13 pursuant to section 286-4.1."
- 14 SECTION 3. This Act shall not apply to applicants who
- 15 submit applications for a motorcycle instruction permit before
- 16 its effective date.
- 17 SECTION 4. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.

PURPOSE:

To require completion of a basic motorcycle rider course before receiving a motorcycle

instruction permit.

MEANS:

Amend section 286-110, Hawaii Revised

Statues

JUSTIFICATION:

From 2019 to 2023, there were 123 motorcycle fatalities on Hawaii's roadways. Of those,

63 did not have a motorcycle license.

To improve safety, the Department proposes to require that all applicants seeking a motorcycle instruction permit complete a basic motorcycle rider course approved by the Department before being issued a

motorcycle instruction permit.

Impact on the public: The bill would have a positive impact on traffic safety for motorcycle riders and all other roadway users by mandating a basic rider course prior to receiving a motorcycle instruction

permit.

Impact on the department and other agencies:
The bill would reduce motorcycle fatalities

and crashes on Hawaii's roadways.
