### A BILL FOR AN ACT

RELATING TO COMMERCIAL DRIVERS LICENSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

13	(3)	[Is domiciled in the State as defined in title 49 Code

15		State proof of citizenship or lawful permanent

18		October 14, 2021, or obtains a non-domiciled

18	certified.	. If a driver submits a current medical examiner's

- 2 person who is not physically qualified to drive under title 49
- 3 Code of Federal Regulations section 391.41(b)(1) or (2) and who
- 4 is otherwise qualified to drive a motor vehicle may be granted
- 5 an intrastate waiver by the director. The process for granting
- 6 intrastate waivers shall be the same as that for interstate
- 7 waivers in title 49 Code of Federal Regulations section 391.49;
- 8 provided that the intrastate waiver requests shall be submitted
- 9 to the director.
- 10 (b) The examiner of drivers may waive the driving skills
- 11 test specified in this section for a commercial driver's license
- 12 applicant who meets the requirements of title 49 Code of Federal
- 13 Regulations section 383.77 or 383.123(b).
- 14 (c) A commercial driver's license or commercial learner's
- 15 permit, including a provisional or temporary license or permit,
- 16 shall not be issued to a person while the person is subject to a
- 17 disqualification from driving a commercial motor vehicle, or
- 18 while the person's driver's license is suspended, revoked, or
- 19 canceled in any state; or while the person holds a driver's
- 20 license issued by any other state unless the person first
- 21 surrenders that license.

1 (d) A commercial learner's permit may be issued to an 2 individual who holds a valid driver's license, is at least eighteen years of age, meets the qualification standards of 3 4 title 49 Code of Federal Regulations, part 391, subparts B and 5 E, and has passed the written tests required for the desired 6 class of a commercial driver's license. 7 The commercial learner's permit shall not be valid for (e) 8 a period in excess of one hundred eighty days from the date that 9 the applicant passes the general and all required endorsement **10** knowledge tests; provided that, if the applicant is not required 11 to take a knowledge test, the period shall start when the permit 12 is issued. When driving a commercial motor vehicle, the holder of a commercial learner's permit shall be accompanied by a 13 person with a valid commercial driver's license to operate that 14 **15** category of commercial motor vehicle with the proper 16 endorsements. The licensed person shall occupy the seat beside 17 the individual for the purpose of giving instruction in driving 18 the commercial motor vehicle. The commercial learner's permit 19 may be renewed no more than an additional one hundred eighty 20 days without requiring the commercial learner's permit holder to 21 retake the general or endorsement knowledge tests, and the 22 applicant requalifies meeting the requirements of subsection

- 1 (d). The commercial learner's permit holder is eligible to take
- 2 the commercial driver's license skills test no earlier than
- 3 fourteen days after obtaining the permit.
- 4 (f) The examiner of drivers may waive the knowledge and
- 5 skills tests specified in this section for any person who is at
- 6 least twenty-one years of age and who possesses a valid
- 7 commercial driver's license issued by any state of the United
- 8 States, Mexico, or a province of Canada that issues licenses in
- 9 accordance with the minimum federal standards for the issuance
- 10 of commercial driver's licenses. The examiner of drivers shall
- 11 accept the test scores of a Hawaii commercial learner's permit
- 12 holder who completes training in another state in the United
- 13 States and is tested in compliance with federal motor carrier
- 14 safety regulations by that state in association with the
- 15 training. The testing state shall electronically transmit in a
- 16 secure manner the skills test results directly to the examiner
- 17 of drivers, and if the applicant passed, and meets all other
- 18 requirements, a Hawaii commercial driver's license shall be
- 19 issued. To retain a hazardous materials endorsement, the
- 20 applicant shall pass the knowledge test for a hazardous
- 21 materials endorsement and be determined by the federal

- 1 Transportation Security Administration not to pose a security
- 2 risk warranting denial of the endorsement.
- 3 (g) Every applicant shall successfully complete the
- 4 commercial driver's license general knowledge test before being
- 5 issued a commercial learner's permit. A driver holding a valid
- 6 commercial driver's license who seeks an upgrade for which a
- 7 skills test is required shall also pass the appropriate
- 8 knowledge test before obtaining a commercial learner's permit.
- 9 Beginning February 7, 2022, except for a driver holding a valid
- 10 commercial driver's license or commercial learner's permit that
- 11 was obtained before February 7, 2022, every applicant shall
- 12 complete the entry-level driver training requirements as
- 13 specified in title 49 Code of Federal Regulations part 380,
- 14 subpart F, and be verified with the Federal Motor Carrier Safety
- 15 Administration Training Provider Registry before taking the
- 16 skills test for a class A or class B commercial driver's
- 17 license, passenger endorsement, or school bus endorsement, and
- 18 before taking the knowledge test for a hazardous materials
- 19 endorsement.
- 20 (h) Beginning November 18, 2024, the examiner of drivers
- 21 shall not issue, renew, transfer, or upgrade a commercial
- 22 driver's license; renew the hazardous materiala endorsement; or

1	issue, renew, or upgrade a commercial learner's permit; if the
2	results of a query to the Federal Motor Carrier Safety
3	Administration's Drug and Alcohol Clearinghouse is that the

#### Report Title:

Department of Transportation; Limited-Term Non-Domiciled Commercial Driver's Licenses and Non-Domiciled Commercial Learner's Permits; Federal Motor Carrier Safety Administration

#### Description:

Amends section 286-236, HRS, to meet current federal regulations to allow the State to issue a limited-term non-domiciled commercial learner's permit and non-domiciled commercial driver's license for applicants who are unable to provide proof of citizenship or lawful permanent residency.

#### JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO RELATING TO COMMERCIAL DRIVERS LICENSING.

PURPOSE:

To allow the State to issue a limited-term non-domiciled commercial learner's permit (CLP) and limited-term commercial driver's license (CDL) for applicants who are unable to provide proof of citizenship or lawful permanent residency.

MEANS:

Amend section 286-236, Hawaii Revised Statutes.

JUSTIFICATION:

In June of 2024, the Federal Motor Carrier Safety Administration (FMCSA) notified the State that citizens of the Freely Associated States (FAS), which include the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau, are eligible only for the limited-term non-domiciled CDLs and CLPs described in Title 49 of the Code of Federal Regulations, sections 383.71(f) and 383.73(f). The FMCSA issued a finding against the State relative to the State's CDL program when it discovered that the State had been issuing full-term CDLs and CLPs to citizens of the FAS.

Authorizing the issuance of a limited-term non-domiciled CLP and CDL would allow the State to comply with FMCSA licensing requirements as well as allow other foreign citizens who are unable to provide proof of citizenship or lawful permanent residency the opportunity to obtain a limited-term CLP/CDL in Hawaii.

Impact on the public: The bill would provide all foreign citizens who are unable to provide proof of citizenship or lawful permanent residency an opportunity to obtain

a limited-term non-domiciled CLP/CDL in Hawaii.

Impact on the department and other agencies:
The bill would allow the State to comply
with FMCSA requirements for issuance of
limited-term non-domiciled CLPs and CDLs to
citizens not domiciled in the United States.
