MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Act 117, Session Laws of Hawaii 2024,
- 5 transferred the enforcement of the motor carrier law from the
- 6 public utilities commission to the department of transportation
- 7 without appropriations to fund positions and administrative
- 8 costs. The purpose of this Act is to make an emergency
- 9 appropriation to provide funds for the department of
- 10 transportation to cover payroll, fringe benefits, and
- 11 administration costs for the enforcement of the motor carrier
- 12 law.
- 13 SECTION 3. There is appropriated out of the state highway
- 14 fund the sum of \$1,500,000 or so much thereof as may be
- 15 necessary for fiscal year 2024-2025 for payroll, fringe
- 16 benefits, and administrative costs for the enforcement of the

5	SECTION 4. Any provision of this Act to the contrary

8	appropriation is made. Any unexpended and unencumbered balance
9	of the appropriation made in this Act as of the close of
10	business on June 30, 2026, shall lapse back to the state highway
11	fund.
