## A BILL FOR AN ACT

RELATING TO UNIVERSITY OF HAWAII CONFERENCE CENTER REVOLVING FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is 2 amended by adding to part V, subpart D, a new section to be 3 appropriately designated and to read as follows: 4 "§304A-University of Hawaii conference center 5 revolving fund. (a) There is established the university of 6 Hawaii conference center revolving fund for conference center 7 programs conducted by the university. The university may 8 establish and collect fees and charges for the costs of 9 providing these services. All fees, charges, and other moneys 10 collected in conjunction with the conference center programs of 11 the university shall be deposited in separate accounts within 12 the revolving fund. The university may establish accounts under 13 the university of Hawaii conference center revolving fund to 14 facilitate the administration of this fund among the various campuses and operating units of the university of Hawaii system. 15 16 The university is authorized to expend funds from the 17 appropriate account in the revolving fund for all costs

13	SECTION 4. On July 1, 2025, all appropriations and
14	encumbrances in the conference center revolving fund, university
15	of Hawaii at Hilo, and in the community college conference
16	center revolving fund shall be transferred to the university of
17	Hawaii conference center revolving fund.
18	SECTION 5. There is appropriated out of the university of
19	Hawaii conference center revolving fund the sum of \$ or
20	so much thereof as may be necessary for fiscal year 2025-2026.
21	The sum appropriated shall be expended by the university of
22	Hawaii for purposes of this Act.

### Description:

Establishes the University of Hawaii Conference Center Revolving Fund and accounts under the fund to facilitate the administration of the revolving fund for conference center programs among various campuses and operating units of the University of Hawaii system. Repeals the Conference Center Revolving Fund, University of Hawaii at Hilo, and the Community College Conference Center Revolving Fund. Transfers all appropriations and encumbrances of the Conference Center Revolving Fund, University of Hawaii at Hilo, and the Community College Conference Center Revolving Fund. and the Community College Conference Center Revolving Fund to the University of Hawaii Conference Center Revolving Fund.

#### JUSTIFICATION SHEET

DEPARTMENT: University of Hawaii

TITLE:

A BILL FOR AN ACT RELATING TO UNIVERSITY OF HAWAII CONFERENCE CENTER REVOLVING FUND.

PURPOSE: To establish the University of Hawaii (UH) Conference Center Revolving Fund for conference center programs conducted by the UH and repeal the Conference Center Revolving Fund, UH at Hilo, and the Community College Conference Center Revolving Fund.

MEANS:

Add a new section to subpart D of part V of chapter 304A, Hawaii Revised Statutes (HRS), and repeal sections 304A-2272 and 304A-2273, HRS.

JUSTIFICATION: Establishing a single conference center revolving fund within the UH system would standardize implementation of conference center programs across the various campuses of UH. This would also allow all campuses to implement these programs while simultaneously eliminating unnecessary duplication of statutes.

<u>Impact on the public:</u> Increased access to conference center usage on UH campuses.

Impact on the department and other agencies: None.
