### A BILL FOR AN ACT

RELATING TO RENEWABLE ENERGY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has a goal 2 to achieve a one hundred per cent renewable portfolio standard 3 by 2045. The legislature recognizes that the Internal Revenue 4 Service offers a clean electricity investment tax credit that 5 provides incentives to support qualified renewable energy 6 facilities that utilize labor paid at prevailing wages. These 7 incentives further support a clean energy economy by improving 8 job quality in clean energy industries and expanding workforce 9 training pathways into these jobs. The legislature notes that 10 Hawaii, unlike other states, does not provide any tax incentives 11 for large-scale renewable energy facilities.

Accordingly, the purpose of this Act is to help the State achieve its clean energy goals by authorizing the public utilities commission to establish preferential rates for the purchase of renewable energy from facilities that meet certain prevailing wage requirements.
