A BILL FOR AN ACT

RELATING TO CANCER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the university of
- 2 Hawaii cancer center is one of seventy-one National Cancer
- 3 Institute-designated cancer centers in the United States. It is
- 4 the only center in Hawaii and the Pacific region. The
- 5 legislature also finds that the university of Hawaii cancer
- 6 center reduces the burden of cancer through research, education,
- 7 patient care, and community outreach, with an emphasis on the
- 8 unique ethnic, cultural, and environmental characteristics of
- 9 Hawaii and the Pacific region.
- 10 Cancer incidence and mortality rates have decreased in
- 11 Hawaii over the last decade, but despite this overall reduction,
- 12 the disparities between ethnic populations continue to be of
- 13 concern. Native Hawaiians continue to have the highest cancer
- 14 incidence and mortality rates among men and women, including
- 15 higher incidences of breast and ovarian cancers. Similarly,
- 16 Filipino women have the highest incidences of ovarian and
- 17 thyroid cancer. The legislature recognizes the need to identify

- 1 the root causes of these disparities. This includes determining
- 2 the health risks associated with living in close proximity to
- 3 certain environmental hazards and exposures, specifically the
- 4 impact of county and private waste landfills in Nanakuli, Oahu,
- 5 on the surrounding Native Hawaiian communities. The legislature
- 6 finds that cancer research focusing on Native Hawaiians, Pacific
- 7 Islanders, and Filipinos is a matter of statewide concern and is
- 8 unique to Hawaii and the university of Hawaii cancer center and
- 9 thus cannot be easily conducted anywhere else in the world.
- 10 The purpose of this Act is to appropriate funds to the
- 11 university of Hawaii cancer center for a multiethnic cohort
- 12 study focusing on the social determinants of health, lifestyles,
- 13 environmental exposures, and resilience factors of Native
- 14 Hawaiians, Pacific Islanders, and Filipinos, including an
- 15 analysis of the health effects and risks of individuals living
- 16 in close proximity to both landfills in Nanakuli, Oahu.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2025-2026 and
- 20 the same sum or so much thereof as may be necessary for fiscal
- 21 year 2026-2027 for the university of Hawaii cancer center to

- 1 conduct a multiethnic cohort study focusing on the social
- 2 determinants of health, lifestyles, environmental exposures, and
- 3 resilience factors of Native Hawaiians, Pacific Islanders, and
- 4 Filipinos, including an analysis of the health effects and risks
- 5 of individuals living in close proximity to landfills in
- 6 Nanakuli, Oahu; provided that the analysis shall utilize water
- 7 and soil sample data from the department of health and other
- 8 agencies.
- 9 The sums appropriated shall be expended by the university
- 10 of Hawaii for the purposes of this Act.
- 11 SECTION 3. The university of Hawaii cancer center shall
- 12 seek federal funding, in addition to the funds appropriated by
- 13 this Act, to complete the multiethnic cohort study identified in
- 14 section 2 of this Act.
- 15 SECTION 4. This Act shall take effect on July 1, 2025.
