A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the people of Hawaii
- 2 have significant concerns about the effects of over-tourism,
- 3 including on the environment. The legislature further finds
- 4 that there is a proliferation of rental kayaks and stand-up
- 5 paddleboards statewide. The legislature also finds that it is
- 6 beneficial for the residents and natural resources of the State
- 7 to regulate commercial rentals where the park itself is the
- 8 location of the watercraft activity. The legislature
- 9 additionally finds that Wailua river state park on Kauai,
- 10 Kealakekua bay state historic park on Hawaii island, and Ahupuaa
- 11 O Kahana state park on Oahu are the only navigable waters within
- 12 a state park.
- 13 Therefore, the purpose of this Act is to require the
- 14 registration and numbering of rental watercraft before they are
- 15 provided or offered to the public for transiting the navigable
- 16 waters of a state park.
