

A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that greater transparency
- 2 is needed regarding graduate outcomes in higher education.
- 3 Publicly reporting data on educational institutions'
- 4 post-graduation employment rates, median incomes, and other
- 5 metrics will allow students and their families to make informed
- 6 decisions about the student's career path and which educational
- 7 institution the student will attend. Tracking and reporting
- 8 this data will also help ensure institutional accountability and
- 9 align higher education programs with the State's workforce
- 10 development needs.
- 11 Accordingly, the purpose of this Act is to:
- 12 (1) Require the university of Hawaii system to collect,
- analyze, and publicly report certain data on graduate
- 14 outcomes;
- 15 (2) Require and appropriate moneys for the development and
- 16 maintenance of a graduate outcomes dashboard; and

1	(3) Appropriate moneys for the establishment of two full-		
2	time equivalent (2.0 FTE) positions with the		
3	university of Hawaii system's office of the vice		
4	president for academic strategy to support this work.		
5	The legislature declares that the purpose of this Act is a		
6	matter of statewide concern.		
7	SECTION 2. Chapter 304A, Hawaii Revised Statutes, is		
8	amended by adding three new sections to part I, subpart A, to be		
9	appropriately designated and to read as follows:		
10	"S304A- Graduate outcomes; data collection and		
11	reporting requirements. (a) The university of Hawaii system		
12	shall collect and publish data on the outcomes of its graduates		
13	within one year, three years, and five years of the student's		
14	graduation.		
15	(b) Data sources for graduate outcomes may include:		
16	(1) State workforce agency employment records;		
17	(2) Graduate surveys;		
18	(3) Federal databases, including the United States Census		
19	Bureau's post-secondary employment outcomes program;		
20	and		
21	(4) Employer-reported data, where applicable.		

1	(0)	The forfowing metrics on graduate outcomes sharr be	
2	tracked and publicly reported:		
3	(1)	<pre>Employment rates;</pre>	
4	(2)	Median earnings;	
5	(3)	The percentage of graduates enrolled in a continuing	
6		education program; and	
7	(4)	Any other metrics the university of Hawaii system	
8		deems_relevant.	
9	(d)	When possible, the data tracked and reported pursuant	
10	to subsection (c) shall be disaggregated by:		
11	(1)	Degree level;	
12	(2)	Field of study; and	
13	(3)	Racial demographic.	
14	(e)	All publicly reported data shall be anonymized to	
15	prevent t	he identification of individual graduates and shall	
16	comply wi	th all applicable state and federal privacy laws,	
17	including	the federal Family Educational Rights and Privacy Act.	
18	<u>§304</u>	A- Graduate outcomes dashboard. The university of	
19	Hawaii sy	stem shall develop and maintain a centralized graduate	
20	outcomes	dashboard, made publicly available on a website, that	

1	presents	in a user-friendly format the university's graduate
2	outcome d	ata. The dashboard shall include:
3	(1)	Interactive tools for filtering data by institution,
4		degree level, field of study, and racial demographic;
5	(2)	Visualization tools, including charts and graphs, to
6		compare outcomes across educational institutions and
7		programs; and
8	<u>(3)</u>	Resources for prospective students, including
9		information on in-demand careers and average student
10		debt levels.
11	<u>§304</u>	A- Reporting requirements. (a) The university of
12	Hawaii sy	stem's office of the vice president for academic
13	strategy	shall submit a report to the legislature no later than
14	twenty da	ys prior to the convening of each regular session,
15	beginning	with the regular session of 2027. The report shall
16	include:	
17	(1)	An annual summary evaluating institutional performance
18		and workforce alignment;
19	(2)	Any other metrics the university of Hawaii system
20		deems relevant; and
21	(3)	Any proposed legislation."

1 SECTION 3. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much 3 thereof as may be necessary for fiscal year 2025-2026 and the 4 same sum or so much thereof as may be necessary for fiscal year 5 2026-2027 for the development and maintenance of a graduate 6 outcomes dashboard, including the establishment of the following positions within the office of the vice president for academic 7 8 strategy: 9 (1) One full-time equivalent (1.0 FTE) position focused on 10 post-graduation workforce outcomes; and 11 (2) One full-time equivalent (1.0 FTE) position focused on 12 data visualization. 13 The sums appropriated shall be expended by university of 14 Hawaii system for the purposes of this Act. 15 SECTION 4. The university of Hawaii system shall begin 16 collecting data as required by this Act no later than one year 17 after the effective date of this Act; provided that the graduate 18 outcomes dashboard shall be made publicly available no later

than two years after the effective date of this Act.

SECTION 5. New statutory material is underscored.
