

A BILL FOR AN ACT

RELATING TO FLOOD MITIGATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that residential flooding
- 2 is a persistent issue across the State, exacerbated by aging
- 3 infrastructure, poor drainage, and increased rainfall due to
- 4 climate change. Flooding not only damages homes but also
- 5 disrupts access to communities, especially in neighborhoods with
- 6 private roads where drainage maintenance is often neglected.
- 7 The purpose of this Act is to address flooding in
- 8 residential areas, including on private roads, by establishing a
- 9 grant program to improve drainage systems, support mitigation
- 10 measures, and provide resources for local communities and
- 11 homeowners.
- 12 SECTION 2. Chapter 179, Hawaii Revised Statutes, is
- 13 amended as follows:
- 14 1. By designating sections 179-1 through 179-4 as part I
- 15 and inserting a title before section 179-1 to read:
- 16 "PART I. GENERAL DUTIES"

| 6 | revenues of the State of Hawaii the sum of \$ or so |
| 7 | much thereof as may be necessary for fiscal year 2025-2026 and |
| 8 | the same sum or so much thereof as may be necessary for fiscal |
| 9 | year 2026-2027 to implement the grant program established by |
| 10 | this Act. |
| 11 | The sums appropriated shall be expended by the department |
| 12 | of land and natural resources for the purposes of this Act. |
