A BILL FOR AN ACT

RELATING TO CESSPOOL CLOSURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there are more than 2 eighty thousand cesspools across the State that pollute 3 groundwater and nearshore water and threaten environmental and 4 human health, and that there is a compelling state interest to 5 close such cesspools. Pursuant to Act 125, Session Laws of 6 Hawaii 2017 (Act 125), cesspools must be closed by January 1, 7 2050, and replaced with approved systems or connected to sewer infrastructure, however the cost impediments on homeowners to 8 9 comply with Act 125 have made the conversions and connections 10 financially challenging.

11 The legislature further finds that in some areas that 12 currently have cesspools, counties are planning to install new 13 wastewater infrastructure to connect existing homes to county 14 sewers. The legislature also finds that connecting homes to 15 sewers to meet the requirements of Act 125 is a solution that 16 should be encouraged in all areas where this is feasible because 17 it is cost-effective for homeowners and treats wastewater to a

higher standard than the most common individual wastewater
 systems that might replace cesspools in more rural areas, such
 as septic systems.

4 The legislature believes that offering a subsidy to 5 homeowners for their portion of the sewer lateral connections 6 and to help cover the cost of cesspools closures for specific 7 projects will encourage counties to plan more sewer 8 infrastructure expansions in the future, ease the burden on 9 homeowners, and protect the health of Hawaii's environment and 10 people. Certain projects already in progress in Ewa Beach on 11 Oahu and in Keaukaha on Hawaii Island are good candidates to pilot a program that offers this type of assistance in order to 12 13 determine if such a program should be established on an ongoing 14 basis to help homeowners within sewer improvement districts with 15 their portion of the costs.

16 Such a program would provide an incentive for counties to 17 look for additional future projects that might be facilitated by 18 the availability of these funds.

19 The purpose of this Act is to appropriate funds to create20 residential sewer connection and cesspool closure subsidy pilot

programs to assist with sewer projects nearing implementation in
 Ewa Beach, Oahu and Keaukaha, Hawaii.

3 SECTION 2. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$12,000,000 or so 5 much thereof as may be necessary for fiscal year 2025-2026 and 6 the same sum or so much thereof as may be necessary for fiscal 7 year 2026-2027 for the city and county of Honolulu to establish 8 a residential sewer connection and cesspool closure subsidy 9 pilot program to:

10 (1) Assist with planned sewer projects for residents in
11 Ewa Beach, Oahu; and

12 (2) Provide rebates to homeowners, create a forgivable13 loan program, or create a program to allow a

14 contractor to claim the funding on behalf of a

15 homeowner;

16 provided that the city and county of Honolulu shall use no more 17 than \$ for the administration of this subsidy pilot 18 program.

19 The sums appropriated shall be expended by the city and20 county of Honolulu for the purposes of this Act.
