RELATING TO GOVERNMENT PROCEDURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There shall be established within the
- 2 house of representatives the intergovernmental task force for
- 3 permit simplification to identify actions taken, challenges
- 4 encountered, and legislative measures necessary to facilitate,
- 5 expedite, and coordinate state and intergovernmental development
- 6 permit processes.
- 7 (b) The speaker of the house of representatives shall
- 8 appoint one member of the house of representatives to serve as
- 9 chairperson of the task force.
- 10 (c) The membership of the task force shall include
- 11 representatives of the following bodies, to be designated by the
- 12 body's head or, in the case of a board or commission, by the
- 13 chairperson:
- 14 (1) The office of the governor;
- 15 (2) The Hawaii state senate;
- 16 (3) The department of business, economic development, and

- 1 (f) The task force shall hold its first meeting no later
- 2 than sixty days after the finalization of its members or
- 3 October 1, 2025, whichever is earlier.
- 4 (q) The members of the task force shall serve without
- 5 compensation for their service on the task force.
- 6 (h) The task force shall cease to exist on June 30, 2027.
- 7 SECTION 2. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2025-2026 and
- 10 the same sum or so much thereof as may be necessary for fiscal
- 11 year 2026-2027 for the staffing and administrative costs of the
- 12 intergovernmental task force for permit simplification.
- 13 The sums appropriated shall be expended by the house of
- 14 representatives for the purposes of this Act.
- 15 SECTION 3. This Act shall take effect upon its approval;
- 16 provided that section 2 shall take effect on July 1, 2025.
