BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) There shall be established within the 2 house of representatives the intergovernmental task force for permit simplification to identify actions taken, challenges 3 4 encountered, and legislative measures necessary to facilitate, 5 expedite, and coordinate state and intergovernmental development permit processes. 7 The speaker of the house of representatives shall appoint one member of the house of representatives to serve as 8 9 chairperson of the task force. 10 The membership of the task force shall include representatives of the following bodies, to be designated by the 11 12 body's head or, in the case of a board or commission, by the 13 chairperson: 14 (1) The office of the governor; 15 (2) The Hawaii state senate;

- 13 year 2026-2027 for the staffing and administrative costs of the

- 16 representatives for the purposes of this Act.
- 17 SECTION 3. This Act shall take effect upon its approval;
- 18 provided that section 2 shall take effect on July 1, 2025.
