## A BILL FOR AN ACT

RELATING TO HOUSING PREFERENCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a shortage
- 2 of affordable housing in Hawaii. Further, many workers face
- 3 difficulty commuting to and from work. Long commutes strain
- 4 transportation infrastructure and exacerbate global warming by
- 5 increasing the emissions of greenhouse gases from vehicles.
- 6 Long commute times also impair worker productivity and personal
- 7 well-being, as well as harm the overall economic productivity of
- 8 the State.
- 9 Allowing people to live closer to where they work will help
- 10 preserve infrastructure, reduce greenhouse gas emissions,
- 11 improve workers' mental health, and help businesses by reducing
- 12 commute times.
- The legislature also finds that housing development may
- 14 displace or adversely affect people who live in the immediate
- 15 vicinity of the projects, and that measures should be taken to
- 16 reduce these effects. Further, people often have strong ties to

- 1 their communities including schools, social networks, and
- 2 commercial establishments.
- 3 Prioritizing affordable housing projects that grant
- 4 preferences for applicants who live or work in the immediate
- 5 vicinity of the projects will help alleviate the shortage of
- 6 workforce housing, reduce traffic and emissions of greenhouse
- 7 gases, mitigate adverse impacts from new development, and build
- 8 stronger communities.
- 9 The purpose of this Act is to allow the Hawaii housing
- 10 finance and development corporation to allow affordable housing
- 11 projects to grant geographic preferences to applicants who live
- 12 or work within five miles of a project.
- 13 SECTION 2. Chapter 201H, Hawaii Revised Statutes, is
- 14 amended by adding a new section to part I to be appropriately
- 15 designated and to read as follows:
- 16 "\\$201H- Geographic preferences. In developing projects
- 17 under this chapter, the corporation may allow projects to grant
- 18 preferences to housing units for applicants whose primary
- 19 physical residence or place of employment is located within five
- 20 miles of the project. The corporation may adopt rules under
- 21 chapter 91 to implement this section."
