
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
EIGHTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$57,450,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2025-2026
5 for the purpose of capital improvement projects for the eighth
6 representative district, as follows:

7	1.	Waimea emergency shelter	
8		Design and construction of an emergency	
9		shelter.

11		Construction	\$9,999,000
12		Total funding	\$10,000,000

13 The sum appropriated for this capital improvement project
14 shall be expended by the county of Hawaii.

17 The sum appropriated for this capital improvement project
18 shall be expended by the department of transportation.

19 8. South Kohala district courthouse

20 Plans for designing, expanding, and

 2 separate waiting areas, accessible
 3 restrooms, secure holding areas, and
 4 expanded office space to accommodate
 5 judicial staff and client services with
 6 energy-efficient systems to support


10 The sum appropriated for this capital improvement project
 11 shall be expended by the judiciary.

12 SECTION 2. The appropriation made for the capital
 13 improvement projects authorized by this Act shall not lapse at
 14 the end of the fiscal year for which the appropriation is made;
 15 provided that all moneys from the appropriation unencumbered as
 16 of June 30, 2028, shall lapse as of that date.

17 SECTION 3. This Act shall take effect on July 1, 2025.
