A BILL FOR AN ACT

RELATING TO CHILD CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in the first quarter
- 2 of fiscal year 2022-2023, more than fifteen thousand families
- 3 with children under the age of thirteen received subsidies from
- 4 the child care connection Hawaii program to help them afford
- 5 child care services. The legislature further finds that child
- 6 care center providers can be faced with disruptions in services
- 7 and possible closure when their operating costs are funded by
- 8 tuition fees because their revenues depend upon ever-changing
- 9 enrollment figures rather than a stable source of funding.
- 10 Accordingly, the purpose of this Act is to establish a
- 11 child care classroom contracts pilot program to develop and
- 12 implement procedures to subsidize child care by contracting for
- 13 classrooms in licensed infant and toddler child care centers or
- 14 group child care centers.
- 15 SECTION 2. (a) The department of human services shall
- 16 establish and implement a child care classroom contracts pilot
- 17 program no later than July 1, 2026.

14		minimum of twelve months and may be extended for the
15		length of the pilot period.
16	(d)	The department of human services may contract with a
17	service p	rovider in accordance with chapter 103F, Hawaii Revised
18	Statutes,	to operate the child care classroom contracts pilot
19	program.	
20	(e)	The pilot program shall cease to exist on June 30,

7	the regular sessions of 2026, 2027, and 2028.		
8	(b) The department of human services shall submit a final		
9	report on the child care classroom contracts pilot program,		
10	including impacts to child care provider stability, family		
11	satisfaction, and any proposed legislation, to the legislature		
12	no later than twenty days prior to the convening of the regular		
13	session of 2029.		
14	SECTION 4. This Act shall take effect on July 1, 2025.
