BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 711-1109, Hawaii Revised Statutes, is 2 amended by amending subsections (1) and (2) to read as follows: 3 "(1) A person commits the offense of cruelty to animals in 4 the second degree if the person intentionally, knowingly, or 5 recklessly: 6 (a) Overdrives, overloads, tortures, torments, beats, causes substantial bodily injury to, or starves any 7 8 animal, or causes the overdriving, overloading, 9 torture, torment, beating, or starving of any animal; 10 (b) Deprives a pet animal of necessary sustenance or 11 causes that deprivation; Mutilates, poisons, or kills without need any animal 12 (C) 13 other than insects, vermin, or other pests; provided that the handling or extermination of any insect, 14

vermin, or other pest is conducted in accordance with

standard and acceptable pest control practices and

HDOA: Cruelty to Animals; Feral Chickens; Private Property; Exemption

Description:

Exempts from the crime of cruelty to animals in the second degree the extermination of insects, vermin, and pests, and the extermination of feral chickens on private property by the property owner; provided that the extermination is conducted in accordance with standard and acceptable pest control practices and rules adopted by the Department of Agriculture. Requires the Department of Agriculture to adopt rules, pursuant to chapter 91, Hawaii Revised Statutes, concerning the humane extermination of insects, vermin, pests, and feral chickens.
