1 (7)Social and health care services; 2 (8) Transportation; and 3 (9) Other services with the goal of alleviating poverty 4 and transitioning individuals and families 5 experiencing homelessness or housing instability into 6 supportive or affordable housing; 7 provided that all kauhale projects shall be connected to public utilities, including water, sewer, and electricity; provided 8 9 further that the kauhale initiative may charge monthly rents of 10 no more than thirty per cent of the area median income level. 11 The sums appropriated shall be expended by the department 12 of human services for the purposes of this part. 13 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 14 much thereof as may be necessary for fiscal year 2025-2026 and 15 the same sum or so much thereof as may be necessary for fiscal 16 **17** year 2026-2027 for the continued implementation of the ohana 18 zones pilot program established under Act 209, Session Laws of 19 Hawaii 2018.

The sums appropriated shall be expended by the department

of human services for the purposes of this Act.

Appropriates funds to the Department of Human Services for the continued implementation of the Kauhale Initiative and Ohana Zones Pilot Program. Requires kauhale to be connected to public utilities. Authorizes monthly rents of no more than 30% of the area median income level to be charged for kauhale. Appropriates funds to the Hawaii Housing Finance and Development Corporation for the development of supportive housing projects and the provision of supportive services for certain households in the supportive housing projects. Effective 7/1/3000. (SD2)
