### A BILL FOR AN ACT

RELATING TO THE HAWAII CHILD NUTRITION PROGRAMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii child
- 2 nutrition programs is the state agency link between the United
- 3 States Department of Agriculture Food and Nutrition Service and
- 4 local program operators. The agency conducts audits, provides
- 5 technical assistance, and disburses federal funds while ensuring
- 6 the programs are managed according to federal requirements.
- 7 The legislature further finds that the Hawaii child
- 8 nutrition programs has a critical role in ensuring the
- 9 department of education reaches the programmatic goal
- 10 established in Act 175, Session Laws of Hawaii 2021, to provide
- 11 at least thirty per cent locally grown food in the State's
- 12 public schools by 2030. However, additional resources and staff
- 13 dedicated to farm-to-school connections are needed to ensure the
- 14 department of education meets its "30 by 30" goal.
- 15 The legislature recognizes that the Hawaii child nutrition
- 16 programs is an agency attached to the department of education
- 17 under the board of education.



1	The purpose of this Act is to:
2	(1) Establish the Hawaii child nutrition programs as an
3	agency in the department of agriculture; and
4	(2) Fund grant-based programs to be administered through
5	the Hawaii child nutrition programs.
6	SECTION 2. The Hawaii Revised Statutes is amended by
7	adding a new chapter to be appropriately designated and to read
8	as follows:

6	(7)	Comply with other requirements as the department of
7		agriculture may prescribe;
8	(8)	Comply with all applicable federal, state, and county
9		statutes, rules, and ordinances;
10	(9)	Agree to indemnify and save harmless the State of
11		Hawaii and its officers, agents, and employees from
12		and against any and all claims arising out of or
13		resulting from activities carried out or projects
14		undertaken with funds provided hereunder and procure
15		sufficient insurance to provide this indemnification
16		if requested to do so by the department of
17		agriculture; and
18	(10)	Agree to make available to the department of
19		agriculture all records the applicant may have
20		relating to the grant, to allow state agencies to
21		monitor the applicant's compliance with this section.

1 In determining recipients for grants related to farm-(e) 2 to-school education and increasing participation in federal 3 child nutrition programs, the agency shall give preference to 4 grantees who propose educational activities that meet one or 5 more of the following: 6 (1)Promotion of healthy food activities; 7 (2) Clear educational objectives; 8 (3) Involvement of parents or the community; Connect to a school or child care center's farm-to-9 (4)10 school or farm-to-early-child-care procurement 11 activities; and 12 (5) Marketing and promoting the program, which will lead 13 to increased pupil knowledge and consumption of 14 Hawaii-grown products. 15 -4 Reports to the legislature. The agency shall 16 submit a report to the legislature on the disbursement of funds 17 awarded pursuant to section -3 no later than twenty days 18 prior to the convening of each regular session." 19 SECTION 3. All employees of the Hawaii child nutrition 20 programs who occupy civil service positions and whose functions 21 are transferred to the department of agriculture by this Act

- 1 shall retain their civil service status, whether permanent or
- 2 temporary. Employees shall be transferred without loss of
- 3 salary, seniority (except as prescribed by applicable collective
- 4 bargaining agreements), retention points, prior service credit,
- 5 any vacation and sick leave credits previously earned, and other
- 6 rights, benefits, and privileges, in accordance with state
- 7 personnel laws and this Act; provided that the employees possess
- 8 the minimum qualifications and public employment requirements
- 9 for the class or position to which transferred or appointed, as
- 10 applicable; provided further that subsequent changes in status
- 11 may be made pursuant to applicable civil service and
- 12 compensation laws.
- Any employee who, prior to this Act, is exempt from civil
- 14 service and is transferred as a consequence of this Act may
- 15 retain the employee's exempt status, but shall not be appointed
- 16 to a civil service position as a consequence of this Act. An
- 17 exempt employee who is transferred by this Act shall not suffer
- 18 any loss of prior service credit, vacation or sick leave credits
- 19 previously earned, or other employee benefits or privileges as a
- 20 consequence of this Act; provided that the employees possess
- 21 legal and public employment requirements for the position to

- 1 which transferred or appointed, as applicable; provided further
- 2 that subsequent changes in status may be made pursuant to
- 3 applicable employment and compensation laws.
- 4 SECTION 4. All appropriations, records, equipment,
- 5 machines, files, supplies, contracts, books, papers, documents,
- 6 maps, and other personal property heretofore made, used,
- 7 acquired, or held by the department of education relating to the
- 8 functions transferred to the department of agriculture shall be
- 9 transferred with the functions to which they relate.
- 10 SECTION 5. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2025-2026 and
- 13 the same sum or so much thereof as may be necessary for fiscal
- 14 year 2026-2027 to fund grants administered by the Hawaii child
- 15 nutrition programs agency for the 2025-2026 school year.
- 16 The sums appropriated shall be expended by the department
- 17 of agriculture for the purposes of this Act.
- 18 SECTION 6. This Act shall take effect on July 1, 3000.
