A BILL FOR AN ACT

RELATING TO STATE FINANCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Pursuant to section 201H-88, Hawaii Revised
- 2 Statutes, the Hawaii housing finance and development corporation
- 3 may secure a line of credit or other instrument of indebtedness,
- 4 in an amount not to exceed \$300,000,000 during the fiscal
- 5 biennium beginning July 1, 2025, and ending June 30, 2027, to
- 6 meet the requirements of federal tax law for the bond volume cap
- 7 recycling program under section 39B-2(f), Hawaii Revised
- 8 Statutes.
- 9 SECTION 2. This Act shall take effect on July 1, 2025.
