## A BILL FOR AN ACT

RELATING TO THE EXECUTIVE OFFICE ON AGING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that low-income subsidy 2 programs, including medicare, medicaid, and medicare savings programs such as medicare part D extra help, can help reduce 3 out-of-pocket costs for individuals with limited income by 4 offsetting their medical and prescription drug costs, such as 5 6 premiums, deductibles, copayments, coinsurance, and lifetime late enrollment penalties. The legislature further finds that 7 although individuals with low income, those who speak English as 8 a second language, or those who live in rural areas may qualify 9 for these programs, they may have no or limited access to the 10 11 benefits, as they may not be aware of or need assistance with 12 the application or eligibility renewal process. The legislature further finds that the Hawaii state health insurance assistance program, administered by the executive office on aging of the department of health, provides free information and one-on-one counseling on medicare. Since 2022, the program has been receiving a significantly higher volume of

- 1 referrals from med-QUEST to assist uninsured or underinsured
- 2 individuals who are losing their medicaid eligibility and need
- 3 to find other health coverage. The overflow and referrals are
- 4 made to community partners within forty-eight hours to help with
- 5 food, housing, utilities, employment, and other needs.
- **6** The legislature also finds that during the COVID-19
- 7 pandemic, the med-QUEST division of the department of human
- 8 services paused disenrollments based on eligibility issues and
- 9 all medicaid members received continuous uninterrupted coverage
- 10 through March 2023, regardless of their change in eligibility.
- 11 Following the 2023 Maui wildfires, the med-QUEST division again
- 12 paused all eligibility disenvollments statewide until the end of
- 13 2023. However, the med-QUEST division has resumed its annual
- 14 eligibility redetermination process, and therefore, people have
- 15 been or will be receiving notices and forms to renew their
- 16 coverage.
- 17 Accordingly, the purpose of this Act is to establish within
- 18 the Hawaii state health insurance assistance program a temporary
- 19 medi-medi project to assist the underserved population in the
- 20 State who may qualify for various low-income subsidy programs to
- 21 gain access to their benefits.

1	SECTION 2. (a) There is established within the Hawaii
2	state health insurance assistance program a medi-medi project to

15	its findings and recommendations regarding the medi-medi
16	project, including any proposed legislation, to the legislature
17	no later than twenty days prior to the convening of each regular
18	session.
19	SECTION 3. There is appropriated out of the general
