A BILL FOR AN ACT

RELATING TO THE LOW-INCOME HOUSING TAX CREDIT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 235-110.8, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 "(b) Each taxpayer subject to the tax imposed by this 4 chapter, who has filed a net income tax return for a taxable 5 year may claim a low-income housing tax credit against the 6 taxpayer's net income tax liability. The amount of the credit 7 shall be deductible from the taxpayer's net income tax 8 liability, if any, imposed by this chapter for the taxable year 9 in which the credit is properly claimed on a timely basis. A 10 credit under this section may be allocated by a partnership or
- 11 limited liability company in any manner agreed to by the
- 12 partners or members regardless of whether the individual or
- 13 entity to receive the credit is deemed to be a partner or member
- 14 for federal income tax purposes, so long as the individual or
- 15 entity is deemed to be a partner or member pursuant to
- 16 applicable state law.

1	A partner or member that is a partnership or limited
