
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR CLAIMS AGAINST THE STATE, ITS
OFFICERS, OR ITS EMPLOYEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. The following sums or so much thereof as may be
3 necessary for fiscal year 2024-2025 are appropriated out of the
4 general revenues of the State of Hawaii to the department of the
5 attorney general for the purpose of satisfying claims for
6 legislative relief as to the following named persons, firms,
7 corporations, and entities, for claims against the State or its
8 officers or employees, for the overpayment of taxes, or for
9 refunds, reimbursements, payments of judgments or settlements,
10 or other liabilities, in the amounts set forth opposite their

12 the purposes of this Act.

13 PART IV

14 SECTION 4. In accordance with section 9 of article VII of
15 the Constitution of the State of Hawaii and sections 37-91 and
16 37-93, Hawaii Revised Statutes, the legislature has determined
17 that the state general fund expenditure ceiling for fiscal year
18 2024-2025 has already been exceeded by \$8,551,795, or one per
19 cent. In addition, the appropriations contained in this Act
20 will cause the state general fund expenditure ceiling for fiscal
21 year 2024-2025 to be further exceeded by \$,
22 or per cent. The reasons for exceeding the general fund
23 expenditure ceiling are that the appropriation made in this Act
24 is necessary to serve the public interest and to meet the needs
25 addressed by this Act.

26 PART V

1 SECTION 5. The sums hereinabove may be paid to the
2 respective persons, firms, corporations, or entities for the
3 satisfaction or settlement of the respectively identified cases,
4 and in several amounts hereinabove set forth or in lesser
5 amounts deemed appropriate, upon checks issued by the
6 comptroller; provided that departments shall obtain the approval
7 of the attorney general before payment of any claim may be made.

8 SECTION 6. Notwithstanding the sums hereinabove stated as
9 interest upon judgments against the State, payment of interest
10 shall be limited to the period from the date of the judgment, if
11 applicable, to thirty days after the effective date of this Act,
12 as provided in section 662-8, Hawaii Revised Statutes, for those
13 cases to which the statute applies.

14 SECTION 7. All unexpended and unencumbered balances of the
15 appropriations made in this Act as of the close of business on
16 June 30, 2026, shall lapse.

17 SECTION 8. If any provision of this Act, or the
18 application thereof to any person or circumstance, is held
19 invalid, the invalidity does not affect other provisions or
20 applications of the Act that can be given effect without the



1 invalid provision or application, and to this end the provisions
2 of this Act are severable.

3 SECTION 9. This Act shall take effect on July 1, 3000.
