A BILL FOR AN ACT

RELATING TO CULTURE AND ARTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the aloha order of
- merit was established to recognize individuals who have made 2
- significant contributions and achieved national or international 3
- recognition in a field either by a single event or by the 4
- totality of work that has been pioneering in that field or 5
- outstanding in the long term. The legislature also finds that 6
- many exceptional and notable individuals are deserving of 7
- recognition specifically for their contributions to Hawaii. 8
- While the aloha order of merit honors individuals who have made 9
- national and international contributions and achieved 10
- 11 recognition, the legislature believes there should be a similar
- program to honor individuals who have made their mark on Hawaii. 12
- 13 Accordingly, the purpose of this Act is to establish the
- Hawaii leadership awards program to honor individuals who have 14
- 15 made considerable and outstanding contributions to Hawaii in
- their respective fields and serve as inspirations to others. 16
