# A BILL FOR AN ACT

RELATING TO THE EXPEDITIOUS REDEVELOPMENT AND DEVELOPMENT OF AFFORDABLE RENTAL HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) Subject to terms and conditions as the director of planning of each county deems appropriate, the 2 3 director may issue a special management area use permit to an 4 applicant to redevelop permanent affordable multi-family rental 5 housing that has been substantially destroyed as a result of a 6 disaster declared by the governor or a mayor as a state of 7 emergency or local state of emergency under chapter 127A, Hawaii 8 Revised Statutes, to develop mixed-use permanent affordable 9 multi-family rental housing on state-owned lands and lands 10 related to the recovery of a disaster.

(b) Except as otherwise provided in this Act or under federal law, the issuance of a special management area use permit under this section shall be exempt from all statutes, charter provisions, ordinances, and rules relating to the issuance of special management area use permits under chapter 205A, Hawaii Revised Statutes.
