RELATING TO INVASIVE SPECIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 141-17, Hawaii Revised Statutes, is
amended to read as follows:

3 "[+]§141-17[+] Fine meshed nets; invasive species; 4 permissible; rules. (a) Notwithstanding any other law to the 5 contrary, fine meshed nets, including monofilament netting of 6 one-half to three-inch mesh, may be used for the protection of 7 plants against invasive species, as determined by the department 8 of agriculture; provided that the fine meshed nets shall be 9 applied in a manner that is unlikely to entangle birds, become 10 dislodged and enter water, or entangle or disturb native and 11 beneficial animals, including but not limited to pollinators, 12 ladybugs or lady beetles, and net-winged insects.

(b) The department of agriculture shall adopt rules in accordance with chapter 91 to implement this section, including but not limited to establishing requirements related to filament diameter, color, and the inclusion of visual cues to prevent non-targeted entanglement; [and] prohibiting the use of mist net
