# A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that cellphone use in 2 schools can be detrimental to student achievement and wellbeing. 3 Research has shown that allowing cellphones in the classroom impacts student focus and engagement, leading to decreased 4 5 academic performance on tests and adversely impacting students' 6 long-term learning retention. Excessive cellphone use can also 7 distract students from in-person socialization, which is 8 critical for students' physical and mental wellbeing.

9 The legislature further finds that there is a growing 10 number of states that are banning or restricting cellphone use 11 in schools. At least nineteen states have passed laws or 12 enacted policies that ban or restrict students' use of 13 cellphones in schools statewide or have recommended that local 14 districts enact bans or restrictive policies. In Hawaii, 15 efforts to ban cellphones in schools has had a positive impact 16 on students, with teachers reporting fewer distractions in class 17 and more social interactions among students.
