A BILL FOR AN ACT

RELATING TO SHIPPING CONTAINER LICENSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the inordinate influx of illegal fireworks, invasive species, narcotics, and other forms of contraband into the State presents a significant threat to public safety, environmental integrity, and the well-being of Hawaii's residents. The unique geographical isolation of Hawaii further necessitates enhanced oversight and regulatory measures to mitigate these threats.

8 The legislature further finds that establishing a nominal 9 licensing program for all shipping containers entering the 10 State, set at a fee of \$1 per container, will provide state 11 agencies with a critical tool to conduct seamless and lawful 12 inspections. This program would ensure that commerce remains 13 unhindered by imposing minimal costs while empowering state 14 authorities to inspect and seize contraband efficiently.

15 Accordingly, the purpose of this Act is to establish a 16 container licensing program that:

9	invalid, the invalidity does not affect other provisions or

11	invalid provision or application, and to this end the provisions		
12	of this Act are severable.		
13	SECTION 4. This Act does not affect rights and duties that		
14	matured, penalties that were incurred, and proceedings that were		
15	begun before its effective date.
