# A BILL FOR AN ACT

RELATING TO PESTICIDE DRIFT MONITORING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that pesticide  
2 applications occurring near schools need to be further studied  
3 to ensure Hawaii's children are not being impacted by off-target  
4 pesticide drift.

5       The legislature also finds that the department of  
6 agriculture has initiated a study on pesticide drift for schools  
7 statewide. The legislature recognizes the importance of this  
8 project to ensure children's safety and appropriate uses of  
9 pesticides for agricultural food security.

10       Accordingly, the purpose of this Act is to appropriate  
11 funds for the continued monitoring of pesticide drift in schools  
12 statewide.

13       SECTION 2. There is appropriated out of the pesticide use  
14 revolving fund the sum of \$323,484 or so much thereof as may be  
15 necessary for fiscal year 2025-2026 and the sum of \$311,903 or  
16 so much thereof as may be necessary for fiscal year 2026-2027,  
17 to carry out the purposes of this Act, including for continued  
18 monitoring of pesticide drift in schools statewide.


1       The sums appropriated shall be expended by the department  
2 of agriculture.

3       SECTION 3. This Act, upon its approval, shall take effect  
4 on July 1, 2025.

## JUSTIFICATION SHEET

DEPARTMENT: Agriculture

TITLE: A BILL FOR AN ACT RELATING TO PESTICIDE  
DRIFT MONITORING.

PURPOSE: To appropriate funds for the continued  
monitoring of pesticide drift in schools  
statewide.

MEANS: Appropriate funds out of the pesticide use  
revolving fund.

JUSTIFICATION: The Department is required to complete a  
statewide drift monitoring study through a  
consent agreement with the United States  
Environmental Protection Agency. The  
Department, in collaboration with the  
University of Hawaii at Manoa's College of  
Tropical Agriculture and Human Resources  
initiated a statewide pesticide drift  
monitoring project in 2023.

Funding for the first two years was  
appropriated by the legislature in 2023-  
2024. Additional funding is needed to  
continue this important program.

Impact on the public: Once completed the  
monitoring data from the project will be  
available to both public and private  
entities to be used to ensure safety for  
children, appropriate mitigation techniques,  
and best management practices are  
implemented.

Impact on the department and other agencies:  
Continued funding will allow the Department  
to continue its study on pesticide drift.

FY27 \$311,903.
