RELATING TO COMPUTER SCIENCE LEGISLATIVE REPORT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The department of education is responsible for 2 putting out an annual computer science legislative report every 3 year by June 30th. However, the department of education would like to include guarter four computer science data from the 4 schools in the report, and the current June 30th due date 5 provides too tight a turnaround for the inclusion of that data. 6 Thus, the department of education would like to push back the 7 due date for the report to the end of the calendar year to 8 9 provide a more robust computer science report.

10 Therefore, the purpose of this Act is to change the due 11 date of the department of education's annual computer science 12 legislative report from June 30 to twenty days prior to the 13 start of the legislative session.

SECTION 2. Section 302A-323, Hawaii Revised Statutes, is
amended by amending subsection (e) to read as follows:

16 "(e) [By June 30, 2022, and by each June 30 thereafter,]
17 At least twenty days prior to the convening of each regular
18 session of the legislature, the superintendent shall submit to

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO COMPUTER SCIENCE LEGISLATIVE REPORT.

PURPOSE: Changes the due date for the Department's computer science legislative report from June 30 to twenty days prior to the start of the legislative regular session.

MEANS: Amend section 302A-323(e), Hawaii Revised Statutes.

JUSTIFICATION: To change the due date for the annual report from June 30 to the end of the calendar year would give the Department additional time to include school calendar quarter four (spring in the calendar year) data in the report.

In addition, 80 percent of the Department's legislative reports are due at the end of the calendar year.

<u>Impact on the public:</u> The public would be better served with a legislative report that includes an analysis with the full school year.

Impact on the department and other agencies: By giving the Department more time to compile and report on computer science data, a more complete analysis can be conducted.
