The prices for school meals may be 9 10 adjusted annually based on the previous year's costs rounded to 11 the nearest five cents; provided that the department by rule shall provide a lower rate or free meals to children based on 12 13 their economic need." 14 SECTION 3. TITLE: A BILL FOR AN ACT RELATING TO SCHOOL MEALS.

- PURPOSE: To reduce the minimum revenue requirement from the sale of school meals from one-half to one-quarter of the cost of preparing the meals, thereby making school meals more affordable for families and increasing student participation in school meal programs.
- MEANS: Amend section 302A-405(a), Hawaii Revised Statutes.
- JUSTIFICATION: Access to nutritious meals is essential for students' academic success and overall wellbeing. However, the increasing cost of school meals places an undue burden on families, leading to reduced student participation in school meal programs. This bill is needed to reduce the required meal cost offset collection, so that the department can make school meals more affordable.
