# A BILL FOR AN ACT

RELATING TO EMERGENCY AEROMEDICAL SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that most rural communities in the State have fewer health care resources 2 3 compared to communities on Oahu, including access to advanced levels of trauma care, medical specialists, and sub-specialists. 4 5 This puts patients in these areas at greater risk of poor 6 outcomes for serious medical conditions such as heart attack, 7 stroke, and traumatic bodily injuries. 8 The legislature further finds that the existing aeromedical 9 services system is overburdened. The State is currently served 10 by only one statewide aeromedical provider, for which there are 11 few viable and cost-effective alternatives in the event of a 12 grounding, for example, due to maintenance issues or crew 13 availability. Emergency aeromedical services are not available 14 for many patients in rural counties and areas. 15 The legislature further finds that one model to improve 16 emergency aeromedical services could be based on the county of
- 18 Hawaii 2003, appropriated general funds for the provision of

emergency aeromedical helicopter services for the county of Maui. Act 213, Session Laws of Hawaii 2007, appropriated 2 general funds for a replacement helicopter for the county of 3 Maui aeromedical emergency medical services program. 4 department of health cost-shares a helicopter with the county of 5 Maui and contracts with a private entity to provide staff and 6 operate the helicopter for emergency aeromedical services. 7 The legislature further finds that the department of health 8 has the authority to establish emergency aeromedical services 9 10 but lacks sufficient resources to implement the Maui model in 11 other rural counties. Accordingly, the purpose of this Act is to appropriate funds to increase the availability of emergency 12 13 aeromedical services. SECTION 2. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2026-2027 and **16** the same sum or so much thereof as may be necessary for fiscal 17 year 2027-2028 to assist the counties, other than the county of 18 19 Kalawao, to increase access to emergency aeromedical services, to be allocated as follows: 20 \$ to the city and county of Honolulu; 21 (2) \$\_\_\_\_\_ to the county of Maui; 22

1	(3) \$ to the county of Hawaii; and				
2	(4) \$ to the county of Kauai.				
3	The sums appropriated shall be expended by each county for				
4	the purposes of this Act.				
5	SECTION 3. There is appropriated out of the general				
6	revenues of the State of Hawaii the sum of \$ or so				
7	much thereof as may be necessary for fiscal year 2026-2027 and				
8	the same sum or so much thereof as may be necessary for fiscal				
9	year 2027-2028 to be deposited into the emergency medical				
10	services special fund.				
11	SECTION 4. There is appropriated out of the emergency				
12	medical services special fund the sum of \$ or so much				
13	thereof as may be necessary for fiscal year 2026-2027 and the				
14	same sum or so much thereof as may be necessary for fiscal year				
15	2027-2028 for the establishment of and operating expenses for				
16	emergency aeromedical services, including the procurement of				
17	helicopters.				
18	The sums appropriated shall be expended by the department				
19	of health for the purposes of this Act.

TITLE:

A BILL FOR AN ACT RELATING TO EMERGENCY

AEROMEDICAL SERVICES.

PURPOSE:

To appropriate funds to the Department to increase the availability of emergency aeromedical services in rural counties.

MEANS:

Appropriate funds.

JUSTIFICATION:

Most rural communities have fewer healthcare resources compared to communities on Oahu, including advanced levels of trauma care, medical specialists, and sub-specialists. Funding to increase access to emergency medical services, including emergency aeromedical services, is needed to improve the quality of health care available to rural communities in the State.

Impact on the public: This bill will provide improved access to medical care for rural communities in the State.

Impact on the department and other agencies:
The resources required to implement or
enhance emergency aeromedical services will
vary by county due to different
infrastructure needs, which include whether
or not the county has a helicopter, hangars,
medical staff, technical staff, and other
equipment. As the appropriations will not
cover the entire cost, each county will need
to share in the costs in an amount to be
determined later.
