### A BILL FOR AN ACT

RELATING TO YOUTH MENTAL HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to a ten-2 year study by the Centers for Disease Control and Prevention,
- 3 nearly all indicators of children and adolescent mental health
- 4 have worsened between 2013 and 2023. Disasters like the
- 5 coronavirus disease 2019 (COVID-19) pandemic and the Maui
- 6 wildfires in August 2023 have increased rates of depression and
- 7 anxiety in our youth.
- 8 The legislature further finds that prevention activities
- 9 related to the promotion of mental health, such as early
- 10 intervention, mental health education, and coping strategies,
- 11 are critical to preventing the escalation of mental health
- 12 disorders in our communities, potentially reducing the need for
- 13 more intensive services in the future.
- 14 Digital platforms that can be accessed with mobile devices
- 15 can provide a powerful public health service, especially for
- 16 youth, by:
