## A BILL FOR AN ACT

RELATING TO AN INTENSIVE MOBILE TEAM PILOT PROGRAM FOR HOUSELESS INDIVIDUALS SUFFERING FROM SERIOUS BRAIN DISORDERS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 There is established an intensive mobile SECTION 1. (a)
- 2 team pilot program within the adult mental health division of
- 3 the department of health to provide intensive mobile team
- 4 services, e.g., "street psychiatry," to chronically houseless
- 5 people suffering from serious brain disorders, including but not

- 7 (b) The pilot program shall establish one intensive mobile
- 8 team in the community mental health center system.
- 9 The intensive mobile team established for the purposes
- 10 of the pilot program shall:
- 11 Establish criteria for pilot program participation,
- which shall include being houseless and suffering from 12
- a serious brain disorder, prioritizing individuals 13
- with schizophrenia or schizoaffective disorder; 14
- 15 (2) Manage no more than forty participants who shall be
- 16 vetted and enrolled by the intensive mobile team;

TITLE:

A BILL FOR AN ACT RELATING TO AN INTENSIVE MOBILE TEAM PILOT PROGRAM FOR HOUSELESS INDIVIDUALS SUFFERING FROM SERIOUS BRAIN DISORDERS.

PURPOSE:

To establish an intensive mobile team pilot program within the Adult Mental Health Division of the Department to provide intensive mobile team services for chronically houseless individuals suffering from serious brain disorders such as schizophrenia and schizoaffective disorder.

MEANS:

Establish a pilot program in session law.

JUSTIFICATION:

Houseless persons with serious brain disorders, such as schizophrenia and schizoaffective disorder, may resist services due to co-morbid medical conditions or a lack of trust in those seeking to assist them.

Street psychiatry is an evolving field in which outreach service providers attempt to reach service-resistant patients where they are and build engagement, rapport, and trust using highly specialized skills and training. If successful, the patient will accept services, become more stabilized, and experience improved health outcomes. In addition, total cost of care for the patient will likely decline as mental health and physical care are delivered more consistently, decreasing the need for more costly care, such as avoidable emergency department use or hospitalization.

This bill is needed to authorize resources for the Department to implement a street psychiatry-based intensive mobile team pilot program. Impact on the public: More intensive services for chronically houseless individuals with schizophrenia or schizoaffective disorder. These individuals will be better served with better guidance and care across the Department and other agencies.

Impact on the department and other agencies: Authorization and resources to implement the IMT pilot project and improve care delivery to treatment-resistant persons.
