### A BILL FOR AN ACT

RELATING TO PUPIL TRANSPORTATION SAFETY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-102, Hawaii Revised Statutes, is
- 2 amended by amending subsection (b) to read as follows:
- 3 "(b) A person operating the following category or
- 4 combination of categories of motor vehicles shall be examined as
- 5 provided in section 286-108 and duly licensed by the examiner of
- 6 drivers:
- 7 (1) Mopeds;
- **8** (2) Motorcycles, except for autocycles as described in
- paragraph (2) of the definition of "motorcycle" in
- section 286-2, and motor scooters;
- 11 (3) Passenger cars of any gross vehicle weight rating,
- 12 buses designed to transport fifteen or fewer
- occupants, trucks and vans having a gross vehicle
- 14 weight rating of eighteen thousand pounds or less, and
- autocycles as described in paragraph (2) of the
- definition of "motorcycle" in section 286-2; and
- 17 (4) All of the motor vehicles in category (3) and any
- 18 vehicle that is not a commercial motor vehicle.

impossible or impractical; provided that no exemption shall be 1 granted for the qualifications of individuals driving a bus as 2 defined in section 286-2 and such individuals shall meet school 3 4 vehicle driver qualifications. The department of transportation shall adopt safety 5 rules and standards relating to school vehicles, equipment, and 6 drivers, including but not limited to: 7 8 (1) School vehicle and school vehicle equipment design, construction, and identification; 9 School vehicle driver qualification and training as 10 (2) required by law; 11 12 (3) School vehicle operation; School vehicle maintenance and maintenance records; 13 (4)Special school vehicle safety inspections; 14 (5) Criteria for passenger loading and unloading safety 15 (6) areas; and 16 **17** (7) Procedures and criteria for the granting of exemptions 18 permitted under subsections (b), (c), and (d); 19 provided that the rules and standards shall permit the use of motorcoaches, small buses, or, vans [weighing less than ten 20 thousand pounds] for the transportation of pupils of a day care 21

center, child care facility, headstart program, [and] preschool,

2	private, including any special school for children in the State,

#### Report Title:

DOT; DOE; Pupil Transportation Safety

### Description:

Amends sections 286-102 and 286-181, HRS, to allow exemptions to include use of motorcoaches, small buses, and vans, which may not meet school bus regulations for school bus services, but which shall otherwise meet vehicle requirements and qualifications set forth in chapter 19-143, Hawaii Administrative Rules, to the extent required by the Department of Transportation and the Department of Education, when adult staff chaperone escorts of students are provided while students are being transported between designated locations off-campus and designated locations on-campus.

# JUSTIFICATION SHEET SB. NO. 1479

DEPARTMENT:

Transportation

TITLE:

A BILL FOR AN ACT RELATING TO PUPIL TRANSPORTATION SAFETY

PURPOSE:

To provide exemptions for the use of motorcoaches, small buses, and vans as school vehicles, even though they may not meet school bus regulations, so long as they shall otherwise meet vehicle requirements and qualifications set forth in chapter 19-143, Hawaii Administrative Rules, to the extent required by the Department of Transportation, the Department of Education, and public charter schools, and so long as they provide adult staff chaperone escorts of students while students are being transported between designated locations off-campus and designated locations on-campus.

MEANS:

Amend sections 286-102(b) and 286-181(b)-(e) and (i), Hawaii Revised Statutes (HRS).

JUSTIFICATION:

This bill is necessary to provide pupil transportation. There is a shortage of school bus drivers able to provide services to the Department of Education, public charter schools, and certain independent schools, that has resulted in the Department of Education, public charter schools, and certain independent schools reducing school bus services for qualified students needing transportation to and/or from school.

School bus services are an instrumental component to supporting fulfillment of the State's compulsory education laws that require school attendance for children between the ages of five and eighteen years.

Impact on the public: This bill promotes a solution to the school bus driver shortage to allow individuals transporting students on a small bus, motorcoach, or van between

designated locations off-campus and designated locations on-campus, and to do so with a valid commercial driver's license issued with a "P" endorsement under section 286-239(b)(4), HRS. Currently, individuals operating school buses must have a commercial driver's license with an "S" endorsement, providing for the authorization of driving school buses.

The proposed bill will provide for needed and timely access to and from school for a certain portion of students in the State.

Impact on the department and other agencies: To allow individuals transporting students on a small bus, motorcoach, or van between designated locations off-campus and designated locations on-campus to do so with a valid commercial driver's license issued with a "P" endorsement under section 286-239(b)(4), HRS. Currently, individuals operating school buses must have a commercial driver's license with an "S" endorsement, providing for the authorization of driving school buses.
