BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the state highway
- 2 fund of the State of Hawaii, the sum of \$5,000,000 or so much
- 3 thereof as may be necessary for fiscal year 2025-2026; to be
- 4 deposited into the automated speed enforcement systems program
- 5 special fund established by Act 112, Session Laws of Hawaii
- 6 2024.
- 7 The sum appropriated shall be expended by the department of
- 8 transportation for the purposes of this Act.
- 9 SECTION 2. There is appropriated out of the automated
- 10 speed enforcement systems program special fund the sum of
- 11 \$5,000,000 or so much thereof as may be necessary for fiscal
- 12 year 2025-2026 for the establishment and maintenance of the
- 13 automated speed enforcement systems program.
- 14 The sum appropriated shall be expended by the department of
- 15 transportation for the purposes of this Act.
- 16 SECTION 3. Any provision of this Act to the contrary
- 17 notwithstanding, the appropriation authorized under this Act
- 18 shall not lapse at the end of the fiscal year for which the
