A BILL FOR AN ACT

RELATING TO AVIAN INFLUENZA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that H5 avian influenza
- 2 viruses, also referred to as bird flu, include the H5N1 subtype
- 3 of bird flu virus that has spread globally in birds since its
- 4 initial discovery in 1996 and recently has been detected in
- 5 several mammal species. Bird flu can cause severe illness with
- 6 a high mortality rate among certain bird populations, such as
- 7 poultry, and can cross between species and infect dairy cows.
- 8 According to the Centers for Disease Control and Prevention
- 9 (CDC), as of January 20, 2025, bird flu has been detected in
- 10 every state, with nine hundred twenty-eight dairy herds and
- 11 136,327,394 poultry having been affected. In November 2024, the
- 12 H5N1 bird flu virus was first confirmed in Hawaii in a backyard
- 13 flock of birds in central Oahu. H5 has since been detected
- 14 through wastewater testing in Hilo and on Kauai.
- 15 The legislature also finds that as of January 20, 2025, the
- 16 CDC reported sixty-seven confirmed human cases of bird flu.
- 17 Nearly all the cases occurred in farm workers. While symptoms

- 1 are typically mild, one case did result in death. No human-to-
- 2 human transmission has been reported, and the current risk to
- 3 the public is considered low. However, close monitoring is
- 4 warranted to identify any change in the virus that may increase
- 5 transmissibility or infection severity. Enhanced biosecurity
- 6 will help protect local farms and food production, and increased
- 7 testing of birds will help better understand the spread of bird
- 8 flu in Hawaii. In addition, education will help inform the
- 9 public about bird flu, their risk, and how to stay safe.
- 10 Accordingly, the purpose of this Act is to appropriate
- 11 funds to the department of health and department of agriculture
- 12 to prevent, monitor, and respond to avian influenza in Hawaii.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2025-2026 to
- 16 carry out the purposes of this Act, including to prevent,
- 17 monitor, and respond to avian influenza in the State.
- 18 The sum appropriated shall be expended by the department of
- 19 health for the purposes of this Act.
- 20 SECTION 3. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so

- 1 much thereof as may be necessary for fiscal year 2025-2026 to
- 2 carry out the purposes of this Act, including to prevent,
- 3 monitor, and respond to avian influenza in the State.
- 4 The sum appropriated shall be expended by the department of
- 5 agriculture for the purposes of this Act.
- 6 SECTION 4. This Act shall take effect on July 1, 2025.
