# A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the coconut 2 rhinoceros beetle, scientifically known as oryctes rhinoceros, is an invasive species that threatens coconut palms and other 3 vegetation. The beetle bores into the crowns of coconut trees, 4 5 feeding on the sap and causing severe damage. The beetle's appetite is not limited to coconut palms, and it threatens other 6 tropical plants such as hala, sugarcane, taro, banana, and 7 8 pineapple. From reduced property values and loss of tourism due 9 to dying palms to increased costs for pest control and tree 10 replacement, the economic consequences are vast and significant. The legislature further finds that the coconut rhinoceros 11 12 beetle endangers the State's cultural heritage by damaging plants, including hala and taro, that are integral to native 13 14 Hawaiian practices. The protection of these plants is essential for preserving local traditions and maintaining a balanced 15

1 Joint Base Pearl Harbor-Hickam, the beetle has spread across Oahu and to the islands of Kauai, Maui, and Hawaii. 2 The purpose of this Act is to establish a two-year coconut 3 rhinoceros beetle eradication pilot program under the department 4 of land and natural resources to provide community-based 5 incentives to eradicate the coconut rhinoceros beetle in Hawaii. 6 SECTION 2. For the purposes of this Act: 7 "Coconut rhinoceros beetle" means the invasive species in 8 9 Hawaii that is scientifically known as oryctes rhinoceros. "Community member" means any resident, military personnel 10 member, farmer, cultural practitioner, golf course staffer, 11 green waste or compost facility worker, retailer, landscape 12 13 professional, botanical garden staffer, or maintenance worker. SECTION 3. (a) There is established within the department 14 15 of land and natural resources a two-year coconut rhinoceros beetle eradication pilot program to incentivize community 16 17 members to collect and submit to the department the coconut 18 rhinoceros beetle and its larvae. The Hawaii invasive species council shall oversee the pilot program and ensure the 19 participation of stakeholders, including community members. 20

2 compensate community members for the collection and submission of coconut rhinoceros beetles and larvae captured in the wild. 3 4 The compensation shall be determined by the department in consultation with the Hawaii invasive species council; provided 5 6 that in no event shall the department compensate any person for 7 collecting or submitting any beetle or larva that was bred by human intervention. 8 SECTION 4. The department of land and natural resources 9 10 shall submit a report regarding the coconut rhinoceros beetle 11 eradication pilot program, including its findings, 12 recommendations, and any proposed legislation, to the 13 legislature no later than twenty days prior to the convening of 14 the regular session of 2026. 15 SECTION 5. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 16 or so much thereof as may be necessary for fiscal year 2025-2026 and 17 18 the same sum or so much thereof as may be necessary for fiscal 19 year 2026-2027 for the costs of operating the coconut rhinoceros 20 beetle eradication pilot program, including:
