A BILL FOR AN ACT

RELATING TO BEEKEEPING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that bees are beneficial
- 2 to local pollination processes and native ecosystems and play a
- 3 critically important role in agriculture as they pollinate food
- 4 crops and provide other useful products, including honey and
- 5 wax. Hawaii's tropical weather, climate, and plant diversity
- 6 present ideal conditions for the year-round breeding of queen
- 7 bees, which may be exported to ensure a more genetically
- 8 diverse, adaptive, and resilient global bee stock. Although the
- 9 honeybee is not a species native to Hawaii, it has played a
- 10 significant role in the pollination of plants that support
- 11 agriculture in the State.
- 12 The legislature further finds that the department of
- 13 agriculture currently manages and monitors the beekeeping
- 14 industry in the State. However, its ability to monitor, respond
- 15 to, and prevent disease or pest outbreaks, as well as pursue and
- 16 distribute financial resources available to beekeepers, could be
- 17 more efficiently achieved with more up-to-date data.

1	The	legislature also finds that new beekeepers who do not	
2	have prop	er training or information on how to safely manage bees	
3	may cause harm to both the beekeeping industry or nearby		
4	propertie	s, increasing the risk of personal liability.	
5	Acco	rdingly, the purpose of this Act is to:	
6	(1)	Clarify the registration process for beekeepers with	
7		the department of agriculture;	
8	(2)	Require the department of agriculture to provide	
9		guidance and support to registered beekeepers to help	
10		beekeepers adhere to certain industry standards and	
11		best management practices in beekeeping; and	
12	(3)	Establish a limitation on liability for any registered	
13		beekeeper who follows industry standards and best	
14		practices.	
15	SECT	ION 2. Section 142-100, Hawaii Revised Statutes, is	
16	amended t	o read as follows:	
17	" [-[]	§142-100 Beekeepers, registration; apiary program.[+]	
18	(a) Beek	eepers may register with the department of agriculture,	
19	on forms	prescribed and prepared by the department, which shall	
20	include t	he following information:

3	(2)	Other information that may assist the department in
4		compiling accurate information on Hawaii's beekeeping
5		industry.
6	(b)	The department of agriculture shall keep registration
7	informati	on confidential subject to the limitations on
8	confident	iality imposed under chapter 92F; provided that the
9	[name_and	business address of each registrant shall be made
10	publicly	available by the department; and provided further that
11	the] depa	rtment may compile statistics based on the
12	informati	on[7] pursuant to section 141-1.
13	(c)	The registration shall be effective for a period of
14	[one year	five years, and shall be renewed at the end of the
15	[one year] <u>five-year</u> period.
16	<u>(d)</u>	The department of agriculture shall advise and support
17	the effor	ts of registered beekeepers to adhere to the following
18	industry	standards and best management practices:
19	(1)	Keep colonies at least twenty-five feet from property
20		lines; provided that a distance between ten and
21		twenty-five feet shall be adequate if:

(1) The name, address, and contact information for the

1		(A) Beekeepers ensure that colonies face the
2		direction opposite the property line; or
3		(B) Beekeepers situate colonies behind a flyover
4		barrier that directs bee flight paths away from
5		the property line;
6	(2)	Keep colonies in hives with removable frames that
7		shall be kept in sound and usable condition;
8	(3)	Maintain an adequate and accessible supply of fresh
9		water on-site, including landing sites for the bees to
10		drink from;
11	(4)	Ensure that hives are protected from bright lights at
12		night;
13	<u>(5)</u>	Manage colonies in a controlled manner to prevent
14		swarming;
15	(6)	Adhere to storage and sanitation practices that
16		prevent disease and theft; mitigate pests, including
17		small hive beetles, wax moths, and varroa mites; and
18		support the overall health of the hives;
19	<u>(7)</u>	Thoroughly clean reused hive and beekeeping equipment
20		of hive products, including old comb and honey;

1	<u>(8)</u>	Grow flowers and plant species where practicable for
2	<u>:</u>	all seasons that are suitable for regional climates to
3	<u>:</u>	support bee activity year-round; and
4	<u>(9)</u>	Requeen hives and colonies if the apiary begins to
5	<u>.</u>	demonstrate more aggressive behavior.
6	[-(d) -]	(e) The department of agriculture shall establish an
7	apiary pro	gram, which [may] shall include the following
8	positions,	to carry out the purposes of this [+]section[+]:
9	(1)	One apiary specialist;
10	(2)	One apiary planner; and
11	(3)	Two apiary technicians.
12	<u>(f)</u>	A beekeeper that is actively registered with the
13	department	of agriculture pursuant to subsection (a) and in good
14	faith adhe	res to the industry standards and best management
15	practices	established in subsection (d) shall not be liable for
16	any injury	resulting to any person arising from the beekeeper's
17	apiary, ex	cept for damages that result from the beekeeper's
18	gross negl	igence or wanton acts or omissions.
19	(g)	As used in this section:
20	"Apia	ry" means the assembly of one or more managed colonies
21	and their	hives kept at a single location

1 "Bee" means all life stages of the common domesticated 2 European honeybee. "Bee" does not include wasps, hornets, 3 African subspecies, or Africanized hybrids. 4 "Colony" means an aggregate of bees consisting principally 5 of workers, but ideally also consists of one queen, and includes 6 drones, brood, combs, and honey. 7 "Disease" means any condition adversely affecting bees or their brood, including bacteria, viruses, invertebrate pests, 8 9 and the presence of undesirable genetic characteristics. 10 "Flyover barrier" means a solid wall, fence, dense 11 vegetation, or combination thereof that encourages bees to fly 12 over rather than fly through. "Hive" means a structure of housing for a colony." 13 14 SECTION 3. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$ or so 16 much thereof as may be necessary for fiscal year 2025-2026 and 17 the same sum or so much thereof as may be necessary for fiscal 18 year 2026-2027 for the department of agriculture to register and 19 provide support to beekeepers pursuant to this Act, including 20 the establishment of positions for the department's apiary 21 program.

- 1 The sums appropriated shall be expended by the department
- 2 of agriculture for the purposes of this Act.
- 3 SECTION 4. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 5. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 6. This Act shall take effect on July 1, 2025.
