A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. Chapter 261E, Hawaii Revised Statutes, is	
3	amended by adding a new section to be appropriately designated	
4	and to read as follows:	
5	"§261E- Emergency charter air services. (a) The	
6	commission shall enter into a contract with a qualified charter	
7	air service provider to ensure the availability of emergency air	
8	transportation in cases of emergency when no other air	
9	transportation service is available.	
10	(b) The contract shall require the qualified charter air	
11	service provider to:	
12	(1) Provide services within twenty-four hours of receiving	
13	notice from the commission;	
14	(2) Provide a minimum of five flights per month for	
15	emergency purposes; and	
16	(3) Maintain all certifications, licenses, and insurance	
17	required by state and federal law.

1	(c) Any department or agency of the State may utilize the
2	qualified charter air service provider for emergency air
3	transportation. Any department or agency utilizing the charter
4	air service provider shall reimburse the commission for the cost
5	of the flight services, as determined by the terms of the
6	contract.
7	(d) The commission shall adopt rules pursuant to
8	chapter 91 necessary to carry out the purposes of this section,
9	including but not limited to the procedures for requesting and
10	reimbursing the costs of charter air services."
11	SECTION 2. There is appropriated out of the general
12	revenues of the State of Hawaii the sum of \$ or so
13	much thereof as may be necessary for fiscal year 2025-2026 and
14	the same sum or so much thereof as may be necessary for fiscal
15	year 2026-2027 for the air carrier commission to enter into a
16	contract with a qualified charter air service provider to
17	provide emergency air transportation in accordance with
18	section 1 of this Act.

12 deputy director's designee, and shall be composed of airport and 13 airline transportation stakeholders including but not limited to 14 representatives invited by the chair of relevant:

- **15** (1) Airlines;
- 16 (2) Labor Unions;
- 17 (3) Concessions;
- 18 (4) Hospitality;
- 19 (5) Airport Security;
