Madam and Sir:

Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1034, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC EMPLOYMENT COST ITEMS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate or authorize funds for fiscal biennium 2025-2027 for collective bargaining cost items, including salary and other cost adjustments, for the members of collective bargaining unit (8) and their excluded counterparts.

Your Committee on Conference has amended this measure by:

- (1) Inserting the appropriate figures for fiscal biennium 2025-2027 based upon the ratified collective bargaining agreement for collective bargaining unit (8) as indicated in the Governor's Message dated April 24, 2025;

- (2) Deleting unnecessary expenditure ceiling language;
- (3) Changing the effective date to July 1, 2025; and
- (4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.


As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B. No. 1034, H.D. 1, S.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as H.B. No. 1034, H.D. 1, S.D. 1, C.D. 1.




