Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1173, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TAX LIENS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to require the Department of Taxation to:

- (1) State the assessment date on certificates of tax lien; and
- (2) Issue certificates of discharge when the tax liability on which a lien is based has been satisfied or has become unenforceable by lapse of time.

Your Committee on Conference has amended this measure by changing the effective date to January 1, 2027.
