Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1422, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO MOTOR CARRIERS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to exempt community-based organizations engaged in community-based economic development providing transportation services from the Motor Carrier Law under certain circumstances.

Your Committee on Conference has amended this measure by:

- (1) Removing the sunset date; and
- (2) Making it effective upon approval.





