Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 410, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE BUDGET OF THE OFFICE OF HAWAIIAN AFFAIRS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds for the operating budget for fiscal biennium 2025-2027 for the Office of Hawaiian Affairs.

Your Committee on Conference has amended this measure by:

- (1) Inserting appropriate operating amounts for fiscal biennium 2025-2027;
- (2) Changing the effective date to July 1, 2025; and





