Your Committee on Housing, to which was referred H.B. No. 528 entitled:

"A BILL FOR AN ACT RELATING TO RESIDENTIAL LEASEHOLDS,"

begs leave to report as follows:

The purpose of this measure is to exempt state and county lands leased after July 1, 2025, for an initial period of no less than ninety-nine years from residential leasehold and residential leasehold condominium and cooperative housing corporation requirements.

Your Committee received testimony in support of this measure from the Hawaii Housing Finance and Development Corporation.

Your Committee finds that existing residential leasehold requirements apply to all state and county lands. This measure exempts these lands for an initial period of no less than ninetynine years from state law governing residential leasehold and residential leasehold condominium and cooperative housing corporation requirements.

Your Committee has amended this measure by:

 Changing the effective date to July 1, 3000, to encourage further discussion; and
