Madame:

Your Committee on Finance, to which was referred H.B. No. 649, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SMALL BOAT HARBORS,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Establish the Small Boat Harbor Commercial Vessel Special Fund;
- (2) Increase moorage fees for commercial vessels;
- (3) Require that revenue from the fee increase be used by the Department of Land and Natural Resources for improvements that primarily benefit commercial vessels that utilize state small boat harbors; and
- (4) Authorize the issuance of general obligation bonds, with debt service to be paid from special funds, for repairs of various small boat harbors.




