Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 70, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO CONDOMINIUM,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- Specify that condominium association budget summaries must contain all required information without referring the reader to other portions of the budget; and
- (2) Clarify a condominium unit owner's capacity to enforce compliance with the budget summary and replacement reserves requirements and provide that the condominium association has the burden to prove substantial compliance with those requirements.
