Madam and Sir:

Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 72, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PHARMACY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Beginning January 1, 2026, require that pharmacy technicians be registered with and obtain a certificate of registration issued by the Board of Pharmacy;
- (2) Impose a duty on pharmacists-in-charge to report violations by registered pharmacy technicians to the Board of Pharmacy; and



- (3) Specify that supervising registered pharmacists are responsible for the actions of registered pharmacy technicians and pharmacy interns.

Your Committee on Conference has amended this measure by:

- (1) Deleting the \$20 registration fee for pharmacy technicians;
- (2) Changing its effective date to upon approval; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.






